*AN ORDINANCE BY THE GOVERNING BOARD
OF THE TOWN OF FUQUAY-VARINA, NORTH CAROLINA
AMENDING THE 2040 COMMUNITY VISION LAND USE PLAN*

WHEREAS, the Town of Fuquay-Varina proposed amendment for the upkeep of the 2040 Community Vision Land Use Plan maps and document as is appropriate for a living future vision document, hereinafter described, was duly filed with the Planning Department; and

WHEREAS, the Planning Board held a public hearing on May 19, 2025, and the Board of Commissioners held a public hearing on June 2, 2025; and

WHEREAS, a notice was published in the Wake Weekly newspaper which ran May 9, 2025, and May 16, 2025, for the Planning Board public hearing and ran May 23, 2025, and May 30, 2025, for the Board of Commissioners public hearing; and

WHEREAS, the Town of Fuquay-Varina Planning Board submitted its recommendation to approve the request to the Board of Commissioners as it was found consistent with the Comprehensive Plan and in the best interest of the public, all in accordance with the requirements of the Town of Fuquay-Varina Land Development Ordinance and the provisions of Chapter 160D, Article 6, of the North Carolina General Statutes;

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Town of Fuquay-Varina, North Carolina:

Section 1: 2040 COMMUNITY VISION LAND USE PLAN is amended as follows:

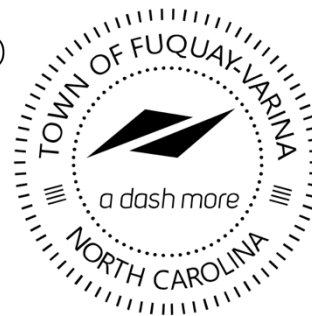
