

**ORDINANCE NO. 2**

**AN ORDINANCE OF THE CITY OF GLENWOOD SPRINGS,  
COLORADO, AMENDING SECTION 020.020.020 REGARDING  
THE COMPOSITION OF MEMBERSHIP ON THE TOURISM  
PROMOTION BOARD.**

**WHEREAS**, Section 020.020.020 of the Glenwood Springs Municipal Code establishes the composition of boards and commissions for the City; and

**WHEREAS**, City Council of the City of Glenwood Springs acknowledges that tourism is of significant importance to the economic growth and stability of the City; and

**WHEREAS**, City Council has determined that Section 020.020.020 should be amended to adjust the composition of membership on the Tourism Promotion Board to allow participation by representatives from the restaurant or retail businesses in the City; and

**WHEREAS**, City Council finds that the proposed Code amendment is consistent with adopted City plans, the Municipal Code, and the City's goals and policies; and

**WHEREAS**, the City Charter of the City of Glenwood Springs requires that an ordinance be enacted to effectuate the amendments.

**NOW, THEREFORE, IT IS ORDAINED BY THE CITY COUNCIL OF THE CITY OF GLENWOOD SPRINGS, COLORADO, THAT:**

**Section 1.** The above recitals are hereby adopted as findings.

**Section 2.** Section 020.020.020 of the Municipal Code is hereby amended as provided for on **Exhibit A** attached hereto and incorporated herein.

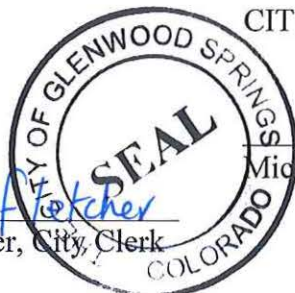
**Section 3.** Any and all ordinances or parts of ordinances in conflict herewith shall hereby be repealed to the extent of the conflict only.

### 020.020.020 Composition of boards and commissions.

The membership of boards and commissions shall be composed of the following persons:

(1) Local Liquor Licensing Board:

...

(13) Tourism Promotion Board:

- a. Two (2) representatives from the tourism related businesses located within the city;
- b. Two (2) representatives from the lodging businesses located within the city;
- c. **One (1) representative from the restaurant or retail businesses located within the city;**
- d.e. One (1) representative from the Glenwood Springs Chamber Resort Association;  
and
- e.d. **Three (3)** ~~Four (4)~~ citizens, at least **two (2)** ~~three (3)~~ who are residents of the City and that shall not have a direct or indirect financial interest in a business referenced in (a), (b) or (c) above and one (1) who is a resident that may have a financial interest in a business referenced in (a), ~~or (b) or (c)~~ above.
