

EMERGENCY ORDINANCE NO. 2017-21

AN ORDINANCE DIRECTING THE DIRECTOR OF FINANCE TO CERTIFY ANY AND ALL UNPAID ASSESSMENTS TO THE BUTLER COUNTY AND WARREN COUNTY AUDITORS FOR ALL UNPAID WATER, SANITARY SEWER, STORM SEWER, TRASH, AND STREET LIGHTING ACCOUNTS, AND DECLARING AN EMERGENCY.

WHEREAS, efforts in the collection of delinquent utility accounts have been unsuccessful; and

WHEREAS, assessment of these unpaid accounts is made pursuant to Ohio Revised Code Section 735.29 and Section 236.03 of the Administrative Code of the Codified Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MONROE, STATE OF OHIO, THAT:

SECTION 1: The Director of Finance is hereby directed to certify the delinquent utility accounts as set forth on Exhibit "A" attached hereto and made a part hereof to the Butler County and Warren County Auditors immediately upon passage of this Ordinance.

SECTION 2: The Director of Finance is hereby ordered to request the County Auditor to place the amounts set forth on Exhibit "A" on the tax list, together with an additional 10% administrative cost, to be collected with and in the same manner as State and county taxes credited to the City of Monroe.

SECTION 3: The Director of Finance is hereby ordered to inform the County Auditor that more than 30 days have intervened from the date of notice of the unpaid amount owed.


SECTION 4: This measure is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare and further for the reason that Council desires to certify the unpaid assessments at the earliest possible date and prior to the deadline of September 11, 2017. Therefore, this measure shall take effect and be in full force from and after its passage.
