#### 22-45 ILLEGAL POSSESSION OF CONTROLLED SUBSTANCES AND MARIJUANA.

No person shall:

- (a) Consume or use any controlled substance including marijuana on any public sidewalk, walkway, entranceway, street, lane or other public place.
- (b) Consume or use any controlled substance including marijuana in a motor vehicle on any highway, street, alley or in any other public place.
- (c) Tender or sell any controlled substance including marijuana to another person in a public place, unless specifically authorized by the laws of the State of West Virginia.
- (d) Possess any controlled substance including marijuana, unless specifically authorized by the laws of the State of West Virginia.
- (e) Possess any controlled substance including marijuana, which was manufactured or acquired in violation of the provisions of WV Code, Chapter 60A.
- (f) Possess any paraphernalia as listed in WV Code Section 60A-4-403a., typically associated with the consumption of any controlled substance including marijuana, unless specifically authorized by the laws of the State of West Virginia.

#### 22-46 PROVISIONS FOR VIOLATIONS OF SECTION 22-45

Any person who is in violation of possession of any controlled substance including marijuana, unless specifically authorized by the laws of the State of West Virginia, in which the amount recovered is less than 15 grams as referenced in Section 22-45(d) and (e) and/or is in violation of the possession of paraphernalia as referenced in section 22-45(f), is guilty of a misdemeanor, and will be referred to the Stonewood Municipal Court.

#### 22-47 PENALTY


(EDITOR'S NOTE: See section 22-34 for general Code penalty if no specific penalty is provided.)

Any person who is in violation of section 22-46 relating to less than 15 grams of any controlled substance including marijuana and/or paraphernalia typically associated with the consumption of a controlled substance including marijuana will be fined not less than five hundred dollars (\$500.00) and not more than one thousand dollars (\$1,000.00), plus all approved court costs.

This Ordinance shall become effective upon passage.
