**AN ORDINANCE AMENDING THE CODE OF ORDINANCES, CITY OF ARCADE, GEORGIA, CHAPTER 30 – NUISANCES, ARTICLE II – NOISE REGULATION; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**

WHEREAS, the City of Arcade, Georgia regulates the level and manner of producing sound and such action's impact on adjacent and neighboring properties; and

WHEREAS, noise regulations provide valuable protection for businesses and regulations to maintain the quality of life for the City and its residents; and

WHEREAS, unregulated construction noise allowed during evening hours in residential areas is particularly offensive to the quality of life of the residents of the City; and

WHEREAS, the Mayor and City Council finds that Chapter 30 – Nuisances, Article II – Noise Regulation needs to be amended to reduce the time that construction noise is permissible in residential districts; and

WHEREAS, in order to minimize the impact of construction noise in residential areas, the City Council desires to change the permitted hours construction noise is permissible in residential areas; and

WHEREAS, it is in the best interests of the citizens of Arcade to provide for appropriate limitations for construction noise in residential areas; and

Now, therefore, IT IS ORDAINED as follows:

**Section 1.**

Section 30-36(5) of the Arcade City Code is amended to delete "11:00 p.m." and substituting in its place "9:30 p.m."

**Section 2.**

All ordinances, or parts of ordinances in conflict herewith are hereby repealed.

**Section 3.**




**Section 4.**


