

**AN ORDINANCE ADOPTING AND AMENDING SECTIONS 26-1 AND 26-2 AND
CREATING SECTION 26-3 PARK AND PLAYGROUND RULES AND REGULATIONS
TO THE MUNICIPAL CODE OF ORDINANCES OF THE VILLAGE OF RANDOM
LAKE, SHEBOYGAN COUNTY, STATE OF WISCONSIN**

26-1. Park and Playground Rules and Regulations.

- (a) No person shall destroy, mutilate, deface, injure or remove any fence, railing, bridge, building, sign, pipe, hydrant, walk, drive or curb, or any fixed or movable property of any kind, nor shall any person injure, break, remove or mutilate any trees, shrubs, plants or flowers in any of the public parks or playgrounds.
- (b) No person shall kill, maim or remove any bird or animal in any public park, except by authority of the police department.
- (c) No person shall post or affix any placard, bill, notice or other paper upon any structure, fence or enclosure in any park or playground.
- (d) No person shall engage in any disorderly conduct or in any lewd or lascivious conduct, act or behavior in or on any public park or playground.
- (e) No fire shall be built in any of the public parks, except at places designated by the village park committee.
- (f) All refuse, paper or waste materials shall be placed in receptacles provided therefor.
- (g) No glass containers shall be allowed in parks.
- (h) No loitering shall be permitted immediately adjacent to and within any public toilet.
- (i) Animals shall not be allowed in the park except on a leash no longer than six (6) feet. Animals must be attended at all times. Owners shall clean up after animals. No animal shall be permitted on the beach or in the swimming area of Lakeview Park.
- (j) No unauthorized vehicle shall be permitted in the park, except in properly designated areas.
- (k) Except as otherwise authorized by the park committee, the hours the village parks shall be open are as follows:
 - (1) Lakeview Park, 6:00 a.m. to 10:00 p.m.
 - (2) Kircher Park, 6:00 a.m. to 11:00 p.m.
 - (3) Bertram Park, 6:00 a.m. to 11:00 p.m.
 - (4) Burr Oak Park, 6:00 a.m. to 10:00 p.m.
- (l) Lakeview Park pavilion use.

- (1) Organizations and individuals may reserve the Lakeview Park pavilion and designated park areas for meetings and gatherings subject to rules and a rent schedule established from time to time by the village board. Applications for such reservations and copies of rules and the current rent schedule are available at the village clerk-treasurer's office.
- (2) No person shall interfere with any organization or person assigned to the Lakeview Park pavilion or other designated park area reserved in accordance with the terms of this subsection. Violators subject to penalty as provided in the village fee schedule.
- (m) Village officials, employees and park attendants are authorized to inform violators and contact property authorities to enforce the intent and purposes of this subsection.
- (n) Parking Prohibited at Lakeview Park. Parking on the drive-way at Lakeview Park from the parking lot to the pavilion is prohibited. Vehicles may drive upon the drive-way for immediate loading and unloading only.

Sec. 26-2. - Boating regulations.

(a) Applicability and enforcement.

- (1) The provisions of this section shall apply to the waters of Random Lake.
- (2) This section shall be enforced by the designated officers of the village and the county.

(b) Intent. The intent of this section is to provide a safe environment for the enjoyment of aquatic recreation consistent with public rights and interests and the capability of the water resources.

(c) State boating and safety laws adopted. State boating laws as found in Wis. Stats. §§ 30.50 to 30.71 are adopted by reference.

(d) Definition. The following words, terms and phrases, when used in this section, shall have the meanings ascribed to them in this subsection, except where the context clearly indicates a different meaning:

Slow-no-wake means that speed at which a boat, pleasure craft or personal motorized watercraft moves as slowly as possible while still maintaining steerage control.

(e) Controlled area. No person shall operate a power or speed boat, pleasure craft or personal motorized watercraft faster than slow-no-wake in the waters of Random Lake beginning south of the swimming buoys to the south shore and from the boat landing to the east limits of the swimming area adjacent to Lakeview Park.

(f) Launch fee.

(1) Power and speed boats, pleasure craft and personal motorized watercraft shall be charged a launch fee as established annually by the village board.

(2) These fees shall be collected either through daily payment or through purchase of a season launch pass from the village office. The village reserves the right to deny, regulate, or revoke any season launch pass for violation of any boating regulations set forth in this chapter or state law. If said pass is revoked, no refund of fee, paid at the time of receiving the pass, shall be made.

(g) Launching regulated. No power and speed boats, pleasure craft and personal motorized watercraft shall be launched anywhere but from the Lakeview Park launch site, except for lake shore property owners having access to the lake.

(h) *Swimming regulated.* Swimming is prohibited within 100 feet of the boat launching pier and the fishing pier.

(i) *Direction of travel.* All persons operating power and speed boats, pleasure craft and personal motorized watercraft are required to travel in a counter clockwise direction around the lake.

(j) *Speed limits at certain hours.* Slow-no-wake speed limits are required between the hours of 7:00 p.m. and 10:00 a.m. or between sunset and 10:00 a.m. if sunset is before 7:00 p.m.

(k) *Number of launchings regulated.* No more than 12 power and speed boats, pleasure craft and personal motorized watercraft may be launched at any time from the Lakeview Park launch site. Once the limit of 12 is reached when one craft leaves the lake, one may be launched.

(l) *Boating restricted at swimming areas.* No person shall operate a boat of any kind within the water area which has been clearly marked by buoys or some other distinguishing device as a bathing or swimming area by the Director of Public Works. This section shall not apply in the case of an emergency or to patrol or rescue craft.

(m) *Penalties.* State boating penalties as found in Wis. Stats. § 30.80 are adopted by reference.

Sec. 26-3. – Beach Regulations.

- (a) *Grilling, Barbecuing Prohibited.* Grilling, barbecuing or otherwise cooking food with gas, wood, charcoal or any other heating source is prohibited on the beach.
- (b) *Smoking and Use of Tobacco Products Prohibited.* Smoking of all kind, including but not limited to, the smoking of cigarettes, electronic cigarettes, vapor cigarettes, and all other tobacco products are prohibited on the beach.
