ORDINANCE NO. 019-2020

**AN ORDINANCE AMENDING SECTION 72.020 OF THE "HIGHLAND PARK CODE OF 1968", AS AMENDED, REGARDING THE RAVINIA FESTIVAL
EAST PARKING PERMIT**

WHEREAS, Chapter 72 of "The Highland Park Code of 1968", as amended ("**City Code**"), regulates the parking of motor vehicles in the City; and

WHEREAS, pursuant to Section 72.020(B)(28) of the City Code, on-street parking in the area of the City generally east of, and in the vicinity of the Ravinia Festival ("**RFE Parking Area**"), is restricted during the Ravinia Festival summer season to vehicles displaying City-issued RFE parking permits; and

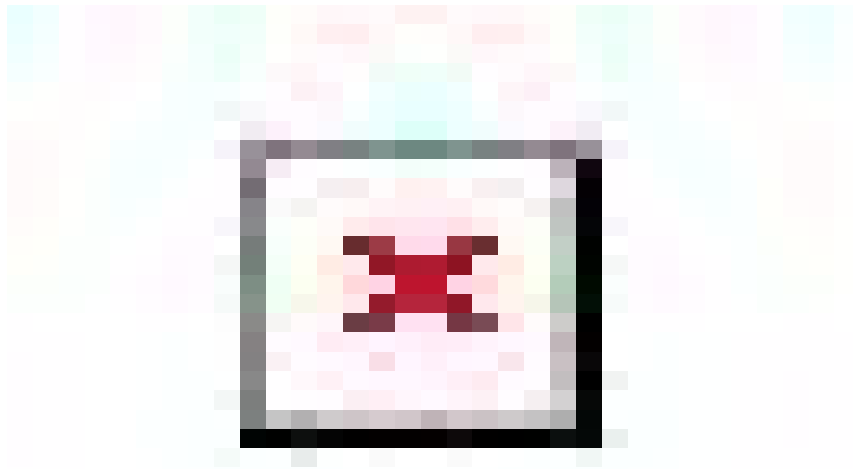
WHEREAS, in order to alleviate traffic circulation and resolve parking issues in the vicinity of the Ravinia Festival, the City Council desires to amend Section 72.020(B)(28) of the City Code to expand the RFE Parking Area to include the Ivy Lane right-of-way; and

WHEREAS, the City Council has determined that it will serve and be in the best interests of the City and its residents to amend Section 72.020(B)(28) of the City Code pursuant to this Ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF HIGHLAND PARK, LAKE COUNTY, ILLINOIS, as follows:

SECTION ONE: RECITALS. The foregoing recitals are incorporated into, and made a part of, this Ordinance as findings of the City Council.

SECTION TWO: RAVINIA EAST NEIGHBORHOOD PARKING PERMITS. Table 72.1, titled "Ravinia East Area Map," of Section 72.020, titled "Public parking lot regulations," of Chapter 72, titled "Parking Regulations," of Title VII, titled "Traffic Regulations," of the City Code is hereby amended further to appear as follows:



SECTION THREE: APPROVAL AND AUTHORIZATION. In accordance with Section 72.001 of the City Code, the City Manager is hereby directed and authorized to install and enforce signs restricting on-street parking in accordance with Section 72.020(B)(28) of the City Code.

SECTION FOUR: PUBLICATION. The City Clerk is hereby directed to publish this Ordinance in pamphlet form pursuant to the Statutes of the State of Illinois.

SECTION FIVE: EFFECTIVE DATE. This Ordinance will be in full force and effect from and after its passage and approval in the manner provided by law.
