ORDINANCE NO. O61-2022

AN ORDINANCE AMENDING CHAPTER 77, TITLE VII OF "THE HIGHLAND PARK CITY CODE OF 1968," AS AMENDED, CONCERNING THE ALLEYWAY BETWEEN PARK AVENUE AND ELM PLACE AND SHERIDAN ROAD AND ST. JOHNS AVENUE (1950-1964 SHERIDAN ROAD)

WHEREAS, pursuant to Section 77.210 of "The Highland Park Code of 1968," as amended ("**City Code**"), certain streets within the City are designated for, and restricted to, one-way vehicular traffic; and

WHEREAS, the City Council desires to amend Section 77.210 of the City Code to restrict vehicular traffic within the public alley located east of St. Johns Avenue and west of Sheridan Road, from Park Avenue to Elm Place, to southbound traffic only; and

WHEREAS, the City Council has determined that that it will serve and be in the best interests of the City to amend Section 77.210 of the City Code pursuant to this Ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF HIGHLAND PARK, LAKE COUNTY, ILLINOIS, as follows:

SECTION ONE: **RECITALS.** The foregoing recitals are incorporated into, and made a part of, this Ordinance as the findings of the City Council.

SECTION TWO: **ONE-WAY STREETS.** Section 77.210, titled "Schedule V. One-Way Street," of Chapter 77, titled "Traffic Schedules," of Title VII, titled "Traffic Regulations," of the City Code is hereby amended further to read as follows:

"Sec. 77.210. - Schedule V. One-Way Street.

(2) One-way streets at all times on the following streets:

* * *

On a certain public alley, for the westerly 216 feet of the east-west public alley in Block 22 located north of Central Avenue and bound by Sheridan Road to the west and Linden Avenue to the east, eastbound only.

On a certain public alley, for the 343.21 feet of the north-south alley located east of St. Johns Avenue and west of Sheridan Road, from Park Avenue to Elm Place, southbound only."

SECTION THREE: PUBLICATION. The City Clerk is hereby directed to publish this Ordinance in pamphlet form pursuant to the Statutes of the State of Illinois.

SECTION FOUR: EFFECTIVE DATE. This Ordinance will be in full force and effect from and after its passage, approval, and publication in the manner provided by law.
