

RESOLUTION NO. R2018.122

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, AMENDING TEMPE CITY CODE, APPENDIX A, THE SCHEDULE OF FEES AND CHARGES FOR STREETS AND SIDEWALKS, ENGINEERING FEES, COLLECTED PURSUANT TO TEMPE CITY CODE SECTION 29-19.

WHEREAS, Tempe City Code Section 29-19(e) provides that City Council shall set permit and license fees for work performed in the City’s public rights-of-way;

WHEREAS, it is appropriate to rename and split the Miscellaneous Trenching Permit into two new permits to better reflect the type of work being performed;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, AS FOLLOWS:

That the following schedule of charges shall be established for permit and license fees for work performed in the City’s public rights-of-way, pursuant to Section 29-19 of the Tempe City Code, and Appendix A of the Tempe City Code is amended, as follows:

SCHEDULE OF FEES AND CHARGES

STREETS AND SIDEWALKS^[7]

29-19 Engineering Fees

All engineering related activities within City owned property, the public right-of-way and public utility easements shall be permitted in accordance with Section 29-19 of the City Code, the City of Tempe Public Works Department Engineering Design Criteria Manual and the City of Tempe Utility Manual. All construction within the right-of-way shall conform to the latest editions of the Maricopa Association of Governments Uniformed Standard Specifications and Details (MAG Specifications and Details), the City of Tempe Supplement to the MAG Specifications and Details, and the Tempe Traffic Barricade Manual.

An annual fee adjustment will be applied to all fees listed. Such fees will be adjusted each July 1, based on the United States Department of Labor, Bureau of Labor Statistics, Consumer Price Index-All Urban Consumers, West Region for All Items (CPI).
