ORDINANCE NO. 1701

AN ORDINANCE OF THE COUNTY OF SUTTER AMENDING SECTION 32-011 THEREOF RELATING TO THE SUTTER COUNTY CLERK-RECORDER'S FEE SCHEDULE

THE BOARD OF SUPERVISORS OF THE COUNTY OF SUTTER ORDAINS AS FOLLOWS:

<u>SECTION 1:</u> The Sutter County Ordinance Code is amended by amending section 32-011 to read in its entirety as follows:

<u>SECTION 2:</u> The Board of Supervisors finds that the fees specified by this ordinance do not exceed the amount reasonably necessary to recover the cost of providing the product or service or the cost of enforcing the regulation for which the fee is levied.

SECTION 3: If any section, subsection, sentence, clause, phrase, or portion of the ordinance is held by a court of competent jurisdiction to be invalid or unconstitutional, such portion shall be deemed a separate, distinct, an independent provision, and the holding shall not affect the validity of the remaining portions of this ordinance.

<u>SECTION 4:</u> This ordinance shall take effect January 14th, 2023, which is more than thirty (30) days after the date of final passage and, together with the names of the members of the Board of Supervisors voting for and against the ordinance, shall be published in the Appeal-Democrat, a newspaper of general circulation, at least once before the expiration of fifteen (15) days from the date of passage.
