LEASE EXTENSION

This Lease Extension entered into this _____ day of March____,

2016 by and between the City of Carlyle, an Illinois municipal corporation, of 850

Franklin Street, Carlyle, Illinois 62231, hereinafter referred to as "Landlord", and Larry

Johnson of Carlyle, Illinois, hereinafter referred to as "Tenant".

The parties have previously entered into a farm lease agreement dated June 22,

2009 and extended by extension agreements dated April 4, 2012, March 14, 2013, March

24, 2014 and January 27, 2015, concerning the following described real estate.

Part of the Northwest Quarter of Section 19, Township 2 North, Range 2 West of the Third Principal Meridian, Clinton County, Illinois and more particularly described as follows:

Beginning at a concrete monument found at Southwest Corner of said Northeast Quarter of Section 19; thence North 00 degrees 16 minutes 00 seconds West (Bearings based on the Illinois State Plane Coordinate System, NAD 83, West Zone) along the West line of said Northeast Quarter of Section 19, a distance of 1035.27 feet to an iron rod and set; thence South 89 degrees 22 minutes 07 seconds East, a distance of 1600.00 feet (Recorded Distance) to an iron rod set; thence South 00 degrees 16 minutes 00 seconds East, a distance of 975.11 feet to an iron rod set on the South line of the Northeast Quarter of Section 19; thence South 87 degrees 49 minutes 57 seconds West along said South line of the Northeast Quarter of Section 19, a distance of 1600.64 feet to the Point of Beginning and containing 36.585 Acres, more or less.

Said farm lease agreement, as extended, was scheduled to terminate on April 1,

2016.

The parties have agreed that the lease would not terminate as scheduled on

April 1, 2016, but should continue in effect.

Therefore, It Is Agreed as follows:

1. The lease dated June 22, 2009, and extended on April 4, 2012, March

14, 2013, March 24, 2014, and January 27, 2015 shall be further extended to April 1, 2017, at which time it shall automatically terminate unless renewed by the mutual agreement of the parties prior to said date.

2. The lease payment terms shall remain the same as in the Janyary 27, 2015 Lease Extension - Tenant hereby agrees to pay Two Hundred Dollars (\$200.00) per tillable acre (that being 29.5 acres), as cash rent. The first payment of Two Thousand Nine Hundred Fifty Dollars (\$2950.00) shall be paid on June 10, 2016, and the second payment of Two Thousand Nine Hundred Fifty Dollars (\$2950.00) shall be paid on June 10, 2016, and the second payment of Two Thousand Nine Hundred Fifty Dollars (\$2950.00) shall be paid on June 10, 2016, and the second payment of Two Thousand Nine Hundred Fifty Dollars (\$2950.00) shall be paid on December 10, 2016.
