

SUMMARY: An ordinance amending Washoe County Code Chapter 45 by modifying definitions under Washoe County Code 45.010 and modifying the creation and composition of the Washoe County Human Services Agency under Washoe County Code 45.020.

ORDINANCE NO. 1712

TITLE: AN ORDINANCE AMENDING WASHOE COUNTY CODE CHAPTER 45 BY MODIFYING THE DEFINITIONS OF "DIVISION DIRECTOR" AND "CHILD CARE" UNDER WASHOE COUNTY CODE 45.010 AND MODIFYING THE CREATION AND COMPOSITION OF THE WASHOE COUNTY HUMAN SERVICES AGENCY AND THE METHOD OF SELECTION OF ITS DIVISION DIRECTORS UNDER WASHOE COUNTY CODE 45.020.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

**SECTION 1.** The Washoe County Code is hereby amended at Sections 45.010(4) and 45.010(5) to amend the definitions of "division director" and "child care" as follows:

**45.010 Definitions**

As used in section 45.010 to 45.385, inclusive, unless the context otherwise requires:

...

- (4) "Division director" means the position of the division director of any division duly created, established, or transferred to the Human Services Agency.
- (5) "Child care" means child care for five or more children, if care for any of those children is for compensation.

**SECTION 2.** The Washoe County Code is hereby amended at Sections 45.020(1) and 45.020(2) to amend the creation and composition of the Washoe County Human Services Agency and the method of selection of its division directors as follows:

**45.020 Human services agency: Creation; composition.**

- (1) There is hereby created the Washoe County human

services agency. The agency consists of five divisions:

...

(c) The division of senior services;

(d) The division of homeless and housing services;  
and

(e) The division of finance and administration.

(2) The agency consists of:

...

(b) Any competitively selected division director, at the discretion of the director;

...


