

SUMMARY: An Ordinance amending Washoe County Code Chapter 11 related to fees charged by the Department of Alternative Sentencing.

ORDINANCE NO. 1722

AN ORDINANCE AMENDING WASHOE COUNTY CODE CHAPTER 11 (ALTERNATIVE SENTENCING) BY AMENDING SECTION 11.090 GOVERNING FEES FOR COST OF SUPERVISION; BY AUTHORIZING THE ADOPTION OF A FEE SCHEDULE FOR SUPERVISION TO BE MADE BY RESOLUTION; AND ALL MATTERS NECESSARILY CONNECTED THEREWITH AND PERTAINING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

Section 1. Chapter 11 of the Washoe County Code is hereby amended, and shall read as follows:

11.090 Fee schedule adoption for cost of supervision:  
Imposition; waiver or reduction.

1. In accordance with NRS 211A.130, the board is authorized to adopt a fee schedule for the cost of supervision imposed on probationers or supervised releasees to defray Washoe County's costs for supervising the probationers or supervised releasees. This fee schedule shall be adopted by board resolution.
2. Except as otherwise provided in subsection 3:
  - (a) The department shall charge each probationer the fees set forth in the schedule adopted pursuant to subsection 1.
  - (b) Payment of all required fees by the probationer is a condition of his suspended sentence or residential confinement.
3. If the chief determines that payment of the fee would result in economic hardship to a probationer, the chief may waive the imposition of, or reduce the amount of, the fee. If the chief waives the imposition of the fee, payment of the fee by the probationer does not constitute a condition of his suspended sentence or residential confinement.




