ORDINANCE NO. 1622

AN ORDINANCE AMENDING WASHOE COUNTY CODE CHAPTER 2 BY ADOPTING SUPPLEMENT NUMBER 14 TO THE WASHOE COUNTY CODE AND ALL CLERICAL AND TECHNICAL CORRECTIONS MADE THEREIN.

THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

SECTION 1. The Washoe County Code is hereby amended by adding the following new section which shall read as follows:

2.630 Adoption of Supplement No. 14 to the Washoe County Code. Supplement No. 14 to the Washoe County Code, together with all clerical and technical revisions to the general ordinances contained therein, is hereby ratified and adopted.

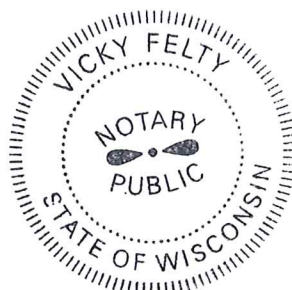
