**ORDINANCE NO. 2019-03-12B**

**AN ORDINANCE AMENDING SECTIONS OF ORDINANCE #2017-11-28D AND  
CHAPTER 15 OF THE CITY OF HEFLIN CODE OF ORDINANCES**

---

WHEREAS, the City Council has adopted the Parks and Recreation Rules and Regulations of the City of Heflin, Alabama, as enacted by Ordinance No. 2017-11-28D and City of Heflin Code of Ordinances Chapter 15; and

WHEREAS, the City Council wishes to amend certain sections of this Chapter at this time by adding an additional Chapters to the Ordinance to include Rule & Regulations at Cahulga Creek Park and Lake;

**THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HEFLIN, ALABAMA,** while in regular session on March 26<sup>th</sup> at 5:30 p.m., as follows:

**Chapter 15-44** as amended is hereby further amended to read:

**Sec. 15-44 – Cahulga Creek Park and Lake Rules**

- (a) Cahulga Creek Park Hours are designated under Section 15-22 of this Ordinance, unless a permit is acquired for additional use
- (b) Swimming is prohibited in the Lake Reservoir and spillway area


- (c) No Gas powered motors allowed in use in reservoir. All gas motors must be out of the water and not in use at all times
- (d) All boats including Kayaks and Canoes must follow all boating safety regulations including necessary floatation devices in boat
- (e) Anyone wishing to utilize the park for overnight purpose, must apply for a special permit with Parks and Recreation
- (f) No motor vehicles are allowed off of designated roadways and parking areas excluding those vehicles used by City of Heflin staff.
- (g) Hunting is not allowed in Cahulga Creek Park area
- (h) Fishing permits must be purchased at Heflin City Hall or Heflin Recreation Center prior to fishing in reservoir, fees set by Heflin City Council
- (i) All persons using the Lake Point Disc Golf course must adhere to all rules and regulations within the PARD Rules & Regulations Ordinance within this chapter
- (j) All pavilions are for public use, and must be rented at Parks and Recreation department for private events
- (k) Restrooms are for public use, and use of restrooms must adhere to all rules and regulations within the PARD Rules & Regulations Ordinance within this chapter

**Section 3.** This Ordinance shall become effective upon its adoption as provided by law.

**Section 4.** That the sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable, and if any phrase, clause sentence, paragraph or section of this Ordinance shall be declared unconstitutional by a court of competent jurisdiction, then such ruling shall not affect any other paragraph and sections, since the same would have been enacted

by the City Council without the incorporation of any such unconstitutional phrase, clause, sentence, paragraph or section.


