12 **Section 1.** **Table 14-6.1-1 of the Land Development Code (being Ord. No. 2012-**
13 **37, § 2, as amended) is amended to add the following permitted accessory uses:**

Section 2. Section 14-12 of the Land Development Code (being Ord. No. 2011-37, § 15, as amended) is amended to add the following definition:

[NEW MATERIAL]

APOTHECARY

A business where alternative medicines are dispensed or compounded by a pharmacist, druggist, herbalist, nutritionist, or licensed provider of medical cannabis.

Section 3. Section 14-12 of the Land Development Code (being Ord. No. 2011-37, § 15, as amended) is amended as follows:

CLINIC

A business in which one (1) or more physicians, dentists, or other licensed health professionals practice their profession exclusively on an out-patient basis. A clinic may provide operating rooms for out-patient surgical procedures.
