Revised Ordinance No. 2021-816

An ordinance amending Section 42-442(b)(2)c.14(ii) of the Code of General Ordinances of the City of Janesville to add a portion of N. Wright Road to the list of streets that allow gasoline service stations as a conditional use and remove portions of North and South Franklin Street, North and South Jackson Street, Mineral Point Avenue, North River Street, North Terrace Street, and North Washington Street from the list of streets with penalties and other relief for violations thereof as set forth in JGO Chapter 42-332.

THE COMMON COUNCIL OF THE CITY OF JANESVILLE DO ORDAIN AS FOLLOWS:

SECTION I. Section 42-442(b)(2)c.14(ii) of the Code of General Ordinances of the City of Janesville is hereby amended to read as follows:

(ii) Location. No station shall be permitted unless it adjoins one of the following streets:
