

ORDINANCE NUMBER 2021-03

AN ORDINANCE OF THE CITY OF GATESVILLE, TEXAS AMENDING ARTICLE II, CHAPTER 8, AVIATION OF THE CODE OF ORDINANCES OF THE CITY OF GATESVILLE; AMENDING SECTION 8-21 SPECIFYING THAT HANGARS ARE TO BE USED ONLY FOR AERONAUTICAL PURPOSES AND HANGAR WAITING LIST PROCESSES; AND DELETING SECTION 8-21(c)(1) RELATING TO HANGAR NUMBER 2.

BE IT ORDAINED BY the City Council of the City of Gatesville, Texas as follows:

Section 1. Article II, Section 8-21 (Airport Hangars), Chapter 8 of the City of Gatesville, Texas Code of Ordinances is amended to add a new subsection (a) to read as follows:

- (a) Hangars located at the Gatesville Municipal Airport are to be used only for aeronautical purposes. Using hangars for other than aeronautical purposes is prohibited.

Section 2. Article II, Section 8-21 (Airport Hangars), Chapter 8, subsection (a) and (b) are renumbered as (b) and (c).

Section 3. Article II, Section 8-21 (Airport Hangars), Chapter 8, subsection (c)(1) is deleted and subsections (c)(2) and (3) are renumbered as (1) and (2).

Section 4. Article II, Section 8-21 (Airport Hangars), Chapter 8 of the City of Gatesville, Texas Code of Ordinances is amended to add a new subsection (f) and (g) to read as follows:

- (f) The City will maintain a hangar waiting list when all available hangars have been rented. When there is a waiting list, hangars will only be rented for aeronautical purposes as defined by FAA policy on use of hangars at federally-obligated airports. Individuals who desire to place their name on the waiting list will provide the following information to the City Finance Department:
 - (1) Name
 - (2) Telephone Number
 - (3) e-mail address
 - (4) aircraft tail number.
- (g) When a hangar(s) becomes available, individuals on the waiting list will be notified in the order they appear on the waiting list and will have five (5) days to accept a hangar. Refusal to respond, or accept the hangar offered will result in the individual's name being removed from the waiting list.

The foregoing Ordinance No. 2021-03 was read the first time and passed to the second reading this 8th day of June, 2021.

The foregoing Ordinance No. 2021-03 was read the second time and passed to the third reading this 22nd day of June, 2021.

The foregoing Ordinance No. 2021-03 was read the third time and was passed and adopted as an Ordinance of the City of Gatesville, Texas this 13th day of July, 2021.
