

**CITY OF SHAWNEE**

**ORDINANCE NO. 3339**

**AN ORDINANCE AMENDING THE EXISTING PROVISIONS OF TITLE 9 OF THE SHAWNEE, KANSAS MUNICIPAL CODE TO INCORPORATE BY REFERENCE THE 2020 36TH EDITION OF THE UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES ("UPOC"), WITH CERTAIN OMISSIONS.**

**NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SHAWNEE, KANSAS:**

**PARAGRAPH 1.** Chapter 9.01 of the Shawnee, Kansas Municipal Code is hereby amended to read as follows:

9.01.010 Incorporating Uniform Public Offense Code for Kansas Cities:

There is hereby incorporated by reference, for the purpose of regulating public offenses within the corporate limits of the City of Shawnee, Kansas, that certain code known as the 2020 36th Edition Uniform Public Offense Code for Kansas Cities ("UPOC"), prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. One (1) official copy of said UPOC shall be marked or stamped as an "Official Copy as Adopted by Ordinance No. 3339", with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change, and to which shall be attached a copy of this Ordinance and filed with the City Clerk, to be open for inspection and available to the public at all reasonable hours. The Police Department, Municipal Judge, Municipal Prosecutors, and all administrative departments of the City charged with enforcement of this Ordinance shall be supplied at the cost of the City, such number of official copies of the Uniform Public Offense Code similarly marked, as may be expedient.

Sections 3.1.1 (Domestic Battery); 3.8 (Violation of Protection from Abuse Order); 3.8.1 (Violation of a Protective Order); 3.13 (Stalking); 6.21 (Taking Wildlife Without Permission on Land posted "By Written Permission Only"); 6.22 (Criminal Hunting); 7.2 (Interference with Law Enforcement); 10.1 (Criminal Use of Weapons); 10.1.1 (Criminal Carrying of a Weapon); 10.5 (Unlawful Discharge of Firearms); 10.6 (Air Gun, Air Rifle, Bow and Arrow, Slingshot, BB Gun or Paint Ball Gun); 10.7 (Seizure of Weapon); 10.8 (Unlawful Aiding, Abetting); 10.9 (Carrying Concealed Explosives); 10.13 (Barbed Wire); 10.18 (Failure to Place or Maintain a Smoke Detector); and 11.11 (Cruelty to Animals) of the Uniform Public Offense Code for Kansas Cities, Edition of 2020, are DELETED and hereby declared to be OMITTED from this incorporating Ordinance and expressly OMITTED from incorporation by reference.

**PARAGRAPH 2.** The previously existing Section 9.01.010 and Section 9.01.020 of the Shawnee, Kansas Municipal Code are hereby repealed.

**PARAGRAPH 3.** If any section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be invalid or unconstitutional, such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The City of Shawnee, Kansas hereby declares that it would have passed this Ordinance, and each section, subsection, clause or phrase hereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

**PARAGRAPH 4.** Savings Clause. Neither the adoption of this Ordinance nor the omission, repeal or amendment of any section or portion thereof shall in any manner affect the prosecution for violation of this Ordinance, or the previously existing provisions of Chapter 9.01, which violations were committed prior to the effective date hereof, nor be construed as a waiver of any license, fee or penalty at said effective date and unpaid under such Ordinance or provision, nor be construed as affecting any of the provisions of such Ordinances or provisions relating to the collection of any such license, fee or penalty, or the penal provisions applicable to the violation thereof, nor to affect the validity of any bond or cash deposit in lieu thereof required to be posted, filed or deposited pursuant to any Ordinance, and all rights and obligations there under shall continue in full force and effect.

**PARAGRAPH 5.** This Ordinance shall take effect and be in force from and after its passage and publication as required by law.





**PARAGRAPH 1.** Chapter 9.01 of the Shawnee, Kansas Municipal Code is hereby amended to read as follows:

9.01.010 Incorporating Uniform Public Offense Code for Kansas Cities:

There is hereby incorporated by reference, for the purpose of regulating public offenses within the corporate limits of the City of Shawnee, Kansas, that certain code known as the 2020 36th Edition Uniform Public Offense Code for Kansas Cities ("UPOC"), prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections, parts or portions as are hereafter omitted, deleted, modified or changed. **PARAGRAPH 2.** The previously existing Section 9.01.010 and Section 9.01.020 of the Shawnee, Kansas Municipal Code are hereby repealed.

**PARAGRAPH 3.** If any section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be invalid or unconstitutional, such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The City of Shawnee, Kansas hereby declares that it would have passed this Ordinance, and each section, subsection, clause or phrase hereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

**PARAGRAPH 4.** Savings Clause. Neither the adoption of this Ordinance nor the omission, repeal or amendment of any section or portion thereof shall in any manner affect the prosecution for violation of this Ordinance, or the previously existing provisions of Chapter 9.01, which violations were committed prior to the effective date hereof, nor be construed as a waiver of any license, fee or penalty at said effective date and unpaid under such Ordinance or provision, nor be construed as affecting any of the provisions of such Ordinances or provisions relating to the collection of any such license, fee or penalty, or the penal provisions applicable to the violation thereof, nor to affect the validity of any bond or cash deposit in lieu thereof required to be posted, filed or deposited pursuant to any Ordinance, and all rights and obligations there under shall continue in full force and effect.

**PARAGRAPH 5.** THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS PASSAGE AND PUBLICATION AS REQUIRED BY LAW.
