ORDINANCE NO. 3382

AN ORDINANCE REPEALING SECTION 2.04.070 OF THE SHAWNEE MUNICIPAL CODE RELATED TO THE DATE AND TIME FOR CITY COUNCIL MEETINGS.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SHAWNEE, KANSAS:

PARAGRAPH 1. Section 2.04.070 of the Shawnee Municipal Code is hereby amended to read as follows.

2.04.070 - Meetings.

The Governing Body shall have regular sessions on the second and fourth Mondays of each month, other than December during which the regular session shall be on the second Monday, commencing at 6:00 p.m. and adjourned sessions therefrom at any time. A regular session on the fourth Monday of December shall be reserved and scheduled only for a special meeting to address emergency items deemed in the best interest of the City. Special meetings may be called by the Mayor or by any three (3) Council Members, the subject of which is to be submitted to the Governing Body in writing and the call and the subject, as well as the action of the Governing Body, shall be entered into the official minutes by the City Clerk; and no other business shall be transacted except that specifically set forth in the written notice of meeting. In the event that a holiday falls on the scheduled meeting date, the City Council meeting will be held the following Tuesday.

PARAGRAPH 3. Upon the effective date of this Ordinance, the previously existing Section 2.04.070 is hereby repealed.


PARAGRAPH 3. This Ordinance shall take effect and be in force from and after its passage and publication as required by law.


