**AN ORDINANCE AMENDING CHAPTER 7 OF THE CODE TO INCLUDE TAXES
IMPOSED IN THE BUSINESS DEVELOPMENT DISTRICT**

WHEREAS, on December 14, 2020, the City Council adopted an ordinance designating and creating the Pekin Business Development District No. 1 (“BDD”); and

WHEREAS, the ordinance increased the Retailer’s and Service Occupation Taxes and the local Hotel/Motel Tax on businesses within the BDD; and

WHEREAS, the City Council desires to amend the City Code to reflect the additional tax.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY
OF PEKIN, TAZEWELL COUNTY, ILLINOIS, THAT:**

Section 1. The findings and recitations set forth above are adopted and found to be true and correct.

Section 2. Chapter 7, Article 1, Section 1 of the Pekin City Code is hereby amended as follows:

Sec. 7-1-1. - Tax imposed—Home rule municipal retailers' occupation tax.

A tax is hereby imposed upon all persons engaged in the business of selling tangible personal property, other than an item of tangible personal property titled or registered with an agency of this State's government, at retail in this Municipality at the rate of 1¾ percent of the gross receipts from such sales made in the course of such business in accordance with the terms, conditions and limitations of 65 ILCS 5/8-11-1; provided, however, that the rate shall be 2¾ percent for businesses located within the Pekin Business Development District No. 1.

Section 3. Chapter 7, Article 1, Section 2 of the Pekin City Code is hereby amended as follows:

Sec. 7-1-2. - Tax imposed—Home rule municipal service occupation tax.

A tax is hereby imposed upon all persons engaged in the business of making sales of service at the rate of 1¾ percent, as imposed by Section 7-1-1, of the selling price of all tangible personal property transferred by such servicemen, either in the form of tangible personal property or in the form of real estate as an incident to a sale of service in accordance with the terms, conditions and limitations of 65 ILCS 5/8-11-5; provided, however, that the rate shall be 2¾ percent for businesses located within the Pekin Business Development District No. 1.

Section 4. Chapter 7, Article 1, Section 5 of the Pekin City Code is hereby amended by the addition of a new subsection (*I*) as follows:

(l) *Business Development District.* There is hereby imposed on the use and privilege of renting a hotel or motel room within the Pekin Business Development District No. 1 a tax of one percent of the rental or leasing charge for each such hotel or motel room rented for each 24-hour period or portion thereof. This tax shall be in addition to the tax imposed in subsection (b)(1) above.

Section 6. This Ordinance is in addition to all other ordinances on the subject and shall be construed therewith excepting as to that part in direct conflict with any other ordinance, and in the event of such conflict, the provisions hereof shall govern.

Section 7. This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law; provided, however, that the tax rates related to the Pekin Business Development District No. 1 shall take effect on the date set forth in Ordinance No. 2935-20/21.





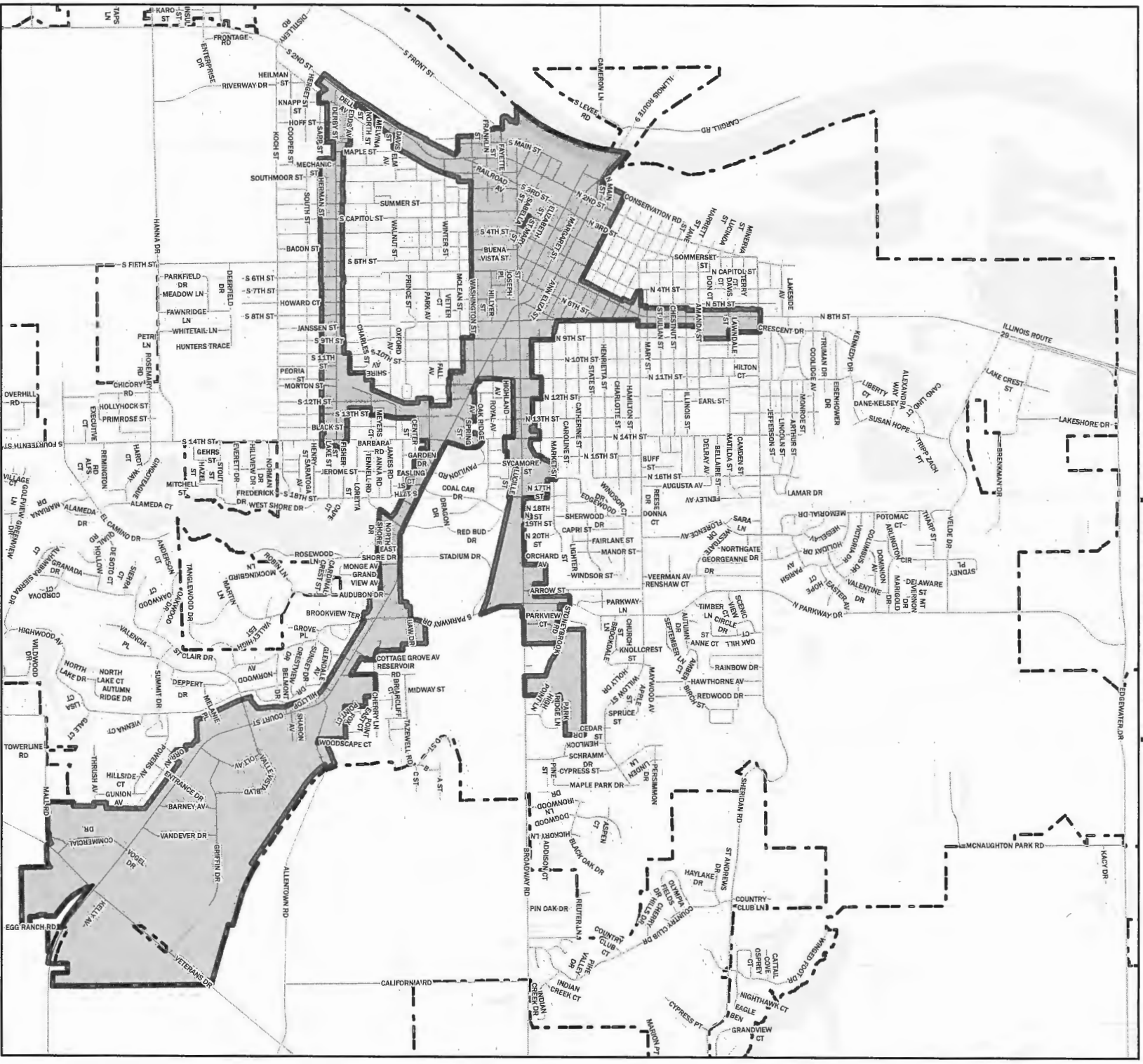
