## **ORDINANCE NUMBER: 2022-12**

## AN ORDINANCE OF THE VILLAGE OF POPLAR GROVE, ILLINOIS AMENDING THE MUNICIPAL CODE BY AMENDING TITLE VI—PUBLIC WAYS AND PROPERTY, CHAPTER 1—STREETS, SIDEWALKS AND PUBLIC WAYS, SECTION 6-1A-1.—CONSTRUCTION REQUIREMENTS AND SPECIFICATIONS

**WHEREAS**, the Village of Poplar Grove, Illinois ("Village) is a municipality organized in accordance with the Constitution of the State of Illinois of 1970; and

**WHEREAS**, the Village has the authority to adopt ordinances and to promulgate rules and regulations governing the use of public right-of-way and that protect the public health, safety, and welfare of its citizens; and

**WHEREAS**, the Village uses the public rights-of-way within its corporate limits to provide essential public services to its residents and businesses, including traffic control, signs, water, sanitary sewer and storm sewer; and

**WHEREAS**, the Village desires to regulate the construction requirements, permitting process, and specifications of sidewalks and driveways within the Village boundaries; and

**WHEREAS**, the Village hereby finds that it is in the best interest of the Village, and the public to identify requirements and standards for the construction requirements and specifications of sidewalks and driveways within the Village boundaries.

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of Poplar Grove, Illinois as follows:

- 1. The above recitals are incorporated herein and made a part hereof.
- 2. That Title VI—Public Ways and Property, Chapter 1—Streets, Sidewalks and Public Ways, Section 6-1A-1. —Construction Requirements and Specifications of the Village Code of Ordinances be amended as follows (deletions as strikethroughs, new language as bold and underlined):

"Section 6-1A-1(b). —Construction Requirements and Specifications, Driveways

E. Specifications.

All plans and specifications for construction, re-surfacing or repair, or reconstruction must conform to the following minimum requirements before a permit for construction or reconstruction shall be issued:

 Driveways for residential or dwelling houses shall be constructed of Portland cement concrete at least Six (6) inches in thickness with at least 6" of compacted IDOT CA-6 Type B aggregate base course. Concrete shall be an approved IDOT PV mix. HMA driveways are also permitted when installed with 3" of asphalt and 10" of compacted IDOT CA-6 Type B base course <u>for portions of</u> <u>driveway work in the right-of-way or affecting sidewalks of public</u> <u>parkways and 3" of asphalt and 8" of compacted IDOT CA-6 Type B base</u> <u>course for other portions of driveway work</u>. IDOT N30FG or N50FG hot mix asphalt shall be utilized. <u>The provisions for the base course in this</u> <u>section shall apply only to newly constructed driveways</u>. <u>Replacement or</u> <u>reconstructed driveways may use the existing base course unless conditions</u> <u>present in the driveway require addition or replacement of base course.</u>"

- 3. Except as amended in this Ordinance, all other provisions and terms of Village Code of Ordinances shall remain in full force and effect as previously enacted except that those ordinances, or parts thereof, in conflict herewith are hereby repealed to the extent of such conflict.
- 4. This Ordinance shall be in full force and effect after its approval, passage and publication in pamphlet form as required by law.
