**ORDINANCE NO. 2021-PZ-C-003-21-SCRIV**

AN ORDINANCE OF THE PINAL COUNTY, ARIZONA, BOARD OF SUPERVISORS CORRECTING SCRIVENER’S ERRORS TO SECTION 6, SECTION 7, SECTION 8 AND SECTION 9 OF ORDINANCE NO. 2021-PZ-C-003-21

WHEREAS, on August 4, 2021, the Pinal County Board of Supervisors (“Board”) adopted Ordinance 2021-PZ-C-003-21, recorded in the office of the Pinal County Recorder on August 5, 2021 at Fee No. 2021-098145 (the “Original Ordinance”), pertaining to zoning regulations amendments to accessory building heights and locations in the Rural Zoning Districts; and

WHEREAS, after adoption of the Original Ordinance, a scrivener’s error was discovered in Section 6 of the Original Ordinance, in that Section 6, being an erroneous reproduction of Section 5, should be deleted, and Sections 7, 8 and 9 should be renumbered to accurately reflect the deletion of Section 6; and

WHEREAS, it has been determined that the body of the Original Ordinance was otherwise correct and accurate and the requisite notices of public hearings, work sessions and Public Hearings in connection with the Original Ordinance were correct and accurate and completed pursuant to A.R.S. §11-813; and

WHEREAS, the Board has determined it is in the best interests of the County to correct the scrivener’s errors to Sections 6, 7, 8 and 9 of the Original Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the Pinal County Board of Supervisors as follows:

**Section 1:** That Section 6 of the Original Ordinance is hereby deleted.

**Section 2:** That Section 7 of the Original Ordinance is renumbered to Section 6

**Section 3:** That Section 8 of the Original Ordinance is renumbered to Section 7

**Section 4:** That Section 9 of the Original Ordinance is renumbered to Section 8

**Section 5:** Other than as expressly set forth in Sections 1-4 above, all remaining provisions of Ordinance No. 2021-PZ-C-003-21 remain unchanged and in full force and effect.

ORDINANCE NO. 2021-PZ-C-003-21-SCRIV

**Section 6:** This Ordinance shall take effect 30 days after the date of its adoption.

**Section 7:** This Ordinance shall be published at least once in a newspaper of general circulation in the County seat after its adoption.
