ORDINANCE No. 63

AN ORDINANCE OF THE CITY OF HAWAIIAN GARDENS REQUIRING PERMITTED USES TO BE CONDUCTED WITHIN ENCLOSED BUILDINGS

THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS DOES ORDAIN AS FOLLOWS:

Section 1:

Sections 258.1 and 258.2 are hereby added to the Los Angeles County Zoning Ordinance, adopted by reference as the Zoning Ordinance of the City of Hawaiian Gardens by Ordinance No. 15 of said City, to read as follows:

"258.1 Notwithstanding any other provision of the ordinance, all uses permitted in the C-4 Zone shall be conducted wholly within an enclosed building, except such uses as:

- 1. Automobile House Trailer Sales (New or Used)
- 2. Automobile Sales (New or Used)
- 3. Automobile Rental
- 4. Automobile Laundries
- 5. Automobile Parking
- 6. Service Stations
- 7. Boat Sales (New or Used)
- 8. Carnivals
- 9. Christmas Trees and Wreaths Sales
- 10. Drive-in Restaurants
- 11. Drive-in Theaters
- 12. Equipment and Trailer Rental
- 13. Flagstone, Ornamental Stones, Bricks and Ornamental Tile (Retail Sales Only)
- 14. Miniature Golf Courses
- 15. Monuments and Tombstones (Retail Sales Only)
- 16. Plumbing Shop Storage Areas, if storage yard enclosed by a solid fence of no less than 6 feet in height
- 17. Nurseries

- 18. Revival Tents
- 19. Swimming Schools
- 20. Trailer Parks
- 21. Similar enterprises customarily conducted in the open and approved by the Planning Commission

258.2 The provisions of Section 258.2 shall not prohibit the maintenance of an open storage area at the rear of the property in connection with the operation of a business otherwise required to be within an enclosed building, provided such storage area is completely enclosed by a solid fence or wall no less than six (6) feet in height and where all articles stored therein are completely shielded from view from outside the property. Such storage area shall not be open to the public and sales operations shall not be conducted on or at such area."

Section 2:

The City Clerk shall certify to the adoption of this Ordinance and cause the same to be posted or published in the manner required by law.
