ORDINANCE NO. ___300

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS AMENDING THE MUNICIPAL CODE BY AMENDING SECTION 9.52.060 (C) (2) RELATING TO FORTUNE TELLING REGULATIONS AND DECLARING THIS TO BE AN URGENCY ORDINANCE TO TAKE EFFECT IMMEDIATELY.

THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS DOES ORDAIN AS FOLLOWS:

Section 1. Chapter 9.52, Section 9.52.060 (C) (2) is hereby amended to read as follows:

"9.52.060 (C)

2. The applicant has posted with the City Clerk, surety bond in the principal sum amount of \$10,000 executed as surety by a good and sufficient corporate surety authorized to do a surety business in the State of California and as a principal by the applicant. The form of the bond shall have been approved by the City Attorney and shall have been given to insure good-faith and fair dealing on the part of the applicant and as a guarantee of indemnity for any and all loss, damage, theft, or other unfair dealings suffered by any patron of the applicant within the City during the term of the permit.

3. Alternately, in lieu of the surety bond as provided in 2. hereinabove, the applicant may post, with the City a cash bond in the sum of \$1,000.00 as a guarantee of indemnity for any and all loss, damage, theft, or other unfair dealings suffered by any patron of the applicant within the City during the term of the permit. The form of the bond shall be approved by the City Attorney and given to insure good-faith and fair dealing on the part of the applicant."


Section 2. URGENCY ORDINANCE. This Ordinance is hereby adopted and passed as an Urgency Ordinance pursuant to the provisions of Sections 36934 and 36937(b) of the Government Code of California upon the following findings and determinations of the City Council.

The regulation of time, place and circumstances of fortune telling, and the reasonable regulation thereof is of immediate concern and is necessary to preserve the health, safety and general welfare of the citizens of Hawaiian Gardens. The requirement of a cash bond will mitigate and avoid the prohibition of practice by further establishing reasonable control and still provide protection to the citizens of Hawaiian Gardens. Therefore, this ordinance shall take effect immediately.

Section 3. SEVERABILITY. If any section, subdivision, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or otherwise invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have adopted this ordinance and each section, subsection, subdivision, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared unconstitutional.

Section 4. The City Clerk shall certify to the adoption of this ordinance and cause it to be published as required by law.
