ORDINANCE NO. 321

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS AMENDING TITLE 12 BY ADDING SECTION 12.08.080 PROHIBITING SKATEBOARDS, ROLLER SKATES AND BICYCLES ON PUBLIC SIDEWALKS

THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS DOES ORDAIN AS FOLLOWS:

Section 1: Title 12 is hereby amended by adding Section 12.08.080 which reads as follows:

"Section 12.08.080: PROHIBITING THE USE OF SKATEBOARDS, ROLLER SKATES AND BICYCLES ON SIDEWALKS IN POSTED AREAS.

a. Prohibited Uses. The City Council, having made a finding that the operation of skateboards, roller skates and bicycles on the sidewalks, or portions thereof will create a hazard to persons and property, does hereby determine and declare said sidewalks, or portions thereof, as areas where the operation of skateboards, roller skates, and bicycles is prohibited.

b. Definitions.

1. Skateboard shall mean any board or flat object which has wheels attached to it by any means whatsoever and which is intended to be propelled by pushing, pulling or the forces of gravity and to which there is not affixed any device or mechanism for steering.

2. Roller skates shall mean any device or shoe which has wheels attached to it by any means whatsoever and which is intended to be propelled by pushing, pulling or the forces of gravity and to which there is not affixed any mechanism for steering.

3. Bicycle shall mean and include any device upon which a person may ride, which is propelled by human power through a system of belts, chains, or gears and which has wheels at least twenty (20) inches in diameter and a frame size of at least fourteen (14) inches.

c. Signs. Whenever any provision of this subsection designates and describes any sidewalk, or any portion thereof, as an area where the operation of skateboards, roller skates, and/or bicycles is prohibited, the City shall place and maintain signs giving notice thereof, which constitutes an entrance to the area which has been so designated.

d. Skateboards, Roller Skates and Bicycles Prohibited. No person shall operate, use, drive or cause to be propelled a skateboard, roller skates or bicycle on any sidewalk, or portion thereof, which has been designated by a Resolution of the City Council, as an area where operation of skateboards, roller skates and bicycles is prohibited"


Section 2: Severability.

If any section, subsection, subdivision, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or otherwise invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have passed this Ordinance and each section, subsection, subdivision, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses or phrases be declared unconstitutional.

Section 3: Effective Date.

This Ordinance shall take effect thirty (30) days from the date of its adoption and prior to the expiration of fifteen (15) days from the adoption hereof the City Clerk shall cause this Ordinance to be published as required by law.
