ORDINANCE NO. 331

AN ORDINANCE OF THE CITY OF HAWAIIAN GARDENS, CALIFORNIA, AMENDING CHAPTER 10. SECTION 10.04.010 and 10.04.020 THE TRAFFIC ORDINANCE, DECLARING THE URGENCY THEREOF AND THAT IT SHALL TAKE EFFECT IMMEDIATELY PURSUANT TO SECTION 36937 OF THE GOVERNMENT CODE.

THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 10.04.010 of Chapter 10 is hereby amended to read as follows:

Section 10.04.010 - Reference to County Traffic Ordinance.  
Reference is made to Title 15 of the Los Angeles County Vehicle and Traffic Code, known as the Traffic Ordinance being an ordinance regulating traffic upon public highways.

SECTION 2. Section 10.04.020 of Chapter 10 is hereby amended to read as follows:

"Section 10.04.020. Title 15 - Vehicles and Traffic Code - County of Los Angeles.

There is hereby adopted as the Traffic Ordinance of the City of Hawaiian Gardens, except as hereafter amended, Title 15 of the County of Los Angeles Vehicle and Traffic Code as amended and in affect as of January 13, 1981.


SECTION 3. Urgency Ordinance. The City Council hereby finds, determines and declares that the immediate preservation of the public health, safety and welfare necessitates the enactment of this ordinance as an urgency measure. A dedication of facts constituting its urgency are declared as follows:

- (1) The City of Hawaiian Gardens incorporates the County of Los Angeles Traffic Code by reference and it constitutes the Traffic Ordinance of the City of Hawaiian Gardens.
- (2) The County of Los Angeles has reviewed, amended and adopted changes in its Code which includes modifications to various laws that constitute violations of the traffic laws.
- (3) In order to effectively enforce violations in a manner consistent with present codes; to assure proper prosecution, and to coordinate with judicial process, it is vital that the present Traffic Ordinance of the City be amended to current law to provide due process, protect the rights of motorists and preserve the safety, health and welfare of the public, it is necessary that this Ordinance take effect immediately pursuant to Section 36937 of the Government Code.

SECTION 4. Severability. If any section, subsection, subdivision, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or otherwise invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have passed this Ordinance and each section, subsection, subdivision, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses or phrases be declared unconstitutional.

SECTION 5. The Mayor is hereby authorized to execute this Ordinance on behalf of the City Council and the City Clerk or her duly appointed deputy is directed to attest thereto.
