## AN ORDINANCE OF THE CITY OF HAWAIIAN GARDENS ADOPTING BY REFERENCE THE LOS ANGELES COUNTY CODE, TITLE 26, BUILDING CODE; TITLE 27, ELECTRICAL CODE; TITLE 28, PLUMBING CODE; TITLE 29, MECHANICAL CODE; AND TITLE 32, FIRE CODE, AND AMENDING THE HAWAIIAN GARDENS MUNICIPAL CODE

WHEREAS, Article 2 of Chapter 1 of Part 1 of Division 1 of Title 5 of the California Government Code (Sections 50022.2, et seq.) authorizes the adoption by reference of County codes; and

WHEREAS, On December 7, 1995, the Los Angeles County Board of Supervisors adopted an Ordinance adopting the 1996 Building, Electrical, Plumbing, Mechanical and Fire Codes, incorporating the 1994 edition of the Uniform Building, Electrical, Plumbing Mechanical and Fire Codes into Los Angeles County Building Code, Title 26; Electrical Code, Title 27; Plumbing Code, Title 28; Mechanical Code, Title 29; and Fire Code, Title 32; and

WHEREAS, on June 11, 1996, the Hawaiian Gardens City Council held a duly noticed public hearing as required by California Government Code Section 50222.3; and

WHEREAS, the Hawaiian Gardens City Council has sufficiently considered all testimony presented to them in order to make the following determination.

<u>Section 1.</u> The City Council HEREBY FINDS that all respects set forth in the Recitals of this Ordinance are true and accurate.

**15.04.020 Code Adopted.** Title 26, Building Code of the Los Angeles County Code, as adopted on December 7, 1995, adopting the Uniform Building Code, 1994 Edition, prepared by the International Conference of Building Officials, except as otherwise provided in said Title 26 and other sections of this Code, is hereby adopted by reference.

Section 3. Section 15.060.020 of the Hawaiian Gardens Municipal Code is hereby amended to read as follows:

**15.06.020 Code Adopted.** Title 27, Electrical Code of the Los Angeles County Code, as adopted on December 7, 1995, adopting the Uniform Electrical Code, 1993 Edition, prepared by the National Electrical Protection Association, except as otherwise provided in said Title 27 and other sections of this Code, is hereby adopted by reference.

Section 4. Section 15.08.020 of the Hawaiian Gardens Municipal Code is hereby amended to read as follows:

**15.08.020 Code Adopted.** Title 29, Mechanical Code of the Los Angeles County Code, as adopted on December 7, 1995, adopting the Uniform Mechanical Code, 1994 Edition, jointly prepared by the International Conference of Building Officials and the International Association of Plumbing and Mechanical Officials, except as otherwise provided in said Title 29 and other sections of this Code, is hereby adopted by reference.

Section 5. Section 15.10.020 of the Hawaiian Gardens Municipal Code is hereby amended to read as follows:

**15.10.020 Code Adopted.** Title 28, Plumbing Code of the Los Angeles County Code, as adopted on December 7, 1995, adopting the Uniform Plumbing Code, 1994 Edition, prepared by the international Association of Plumbing and Mechanical Officials, except as otherwise provided in said Title 28 and other sections of this Code, is hereby adopted by reference.

Section 6. Section 15.20.010A of the Hawaiian Gardens Municipal Code is hereby amended to read, in words and figures, as follows:

<u>15.20.010A Code Adopted</u>. Title 32 of the Los Angeles County Code entitled, "The Fire Code", as that Title currently exists, and/or as it may be amended from time to time by the County of Los Angeles, is hereby adopted by reference, as the Fire Code Ordinance of the City of Hawaiian Gardens.

<u>Section 7.</u> If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance or any part hereof or exhibit hereto is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining portions of this Ordinance. The City Council of the City of Hawaiian Gardens hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase hereof, irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared invalid.

<u>Section 8.</u> This ordinance shall become effective thirty (30) days after the final passage thereof.

<u>Section 9.</u> The City Clerk shall certify to the passage of this ordinance and prior to the expiration of fifteen days from the adoption hereof the City Clerk shall cause this ordinance to be published in the manner prescribed by law.

The City of Hawaiian Gardens, through the Department of Planning and Community Development, is proposing the adoption, by reference, County of Los Angeles' Building Code, Electrical Code, Plumbing Code, Mechanical Code and Fire Code. The following is a summary of the proposed ordinance:

#### A. BUILDING CODE LOS ANGELES COUNTY CODE TITLE 26

The ordinance adopts by reference Title 26 (Building Code) of the Los Angeles County Code and portions of the 1994 section of the Uniforms Building Code. Specifically, it repeals and reinstates existing provisions of Title 26 by renumbering sections to be consistent with the revised format of the Uniform Building Code. This ordinance also eliminates conflicting provisions and makes minor editorial and technical changes to Title 26.

#### B. ELECTRICAL CODE LOS ANGELES COUNTY CODE TITLE 27

The ordinance adopts by reference Title 27 (Electrical Code) of the Los Angeles County Code and the 1993 edition of the National Electrical Code (NEC) prepared by the National Fire Protection Association. The ordinance makes changes to Title 27 of the Los Angeles County Code to clarify existing provisions regarding accreditation of testing laboratories and various editorial changes.

### C. PLUMBING CODE LOS ANGELES COUNTY CODE TITLE 28

The ordinance adopts by reference Title 28 (Plumbing Code) of the Los Angeles County Code and the 1994 Uniform Plumbing Code. Specifically, it reinstates and renumbers existing amendments for consistency with the revised format of the Uniform Plumbing Code. The ordinance also eliminates conflicting provisions and makes editorial and technical changes to Title 28.

#### D. MECHANICAL CODE LOS ANGELES COUNTY CODE TITLE 29

The ordinance adopts by reference Title 29 (Mechanical Code) of the Los Angeles County Code and the 1994 Uniform Mechanical Code. Specifically, it reinstates and renumbers existing amendments for consistency with the revised format of the Uniform Mechanical Code. The ordinance also eliminates conflicting provisions and makes editorial and technical changes to Title 29.

## FIRE CODE

#### LOS ANGELES COUNTY CODE TITLE 32

The ordinance adopts by reference Title 32 (Fire Code) of the Los Angeles County Code and the 1994 Uniform Fire Code. Amendments include information regarding submittal of plans and specifications, evidence of water supply with every application for a building permit, emergency alarm plans, above ground tanks in buildings and transfer requirements for gases and liquids.

Any person interested in the above proceedings may appear at the time and place indicated to testify in support of, or in opposition to, the item. Pursuant to Government Code Section 65009, if this matter is subsequently challenged in court, the challenge may be limited to only those issues raised at the public hearing described in this notice, or in written correspondence delivered to the City of Hawaiian Gardens at, or prior to, the public hearing.

## SUMMARY:

On December 7, 1995, the County Board of Supervisors adopted the 1996 Building, Electrical, Plumbing, Mechanical and Fire Codes for the County of Los Angeles. These codes incorporate the 1994 editions of the Uniform Building, Plumbing, Mechanical and Fire Codes and the 1993 Edition of the Uniform Electrical Code which became effective on January 8, 1996, in Los Angeles County. The City of Hawaiian Gardens adopts by reference these Los Angeles County Codes, which by this action becomes the City's Codes.

## **DISCUSSION:**

The Codes being adopted by reference are based upon the 1994 Uniform Building, Plumbing, Mechanical and Fire Codes, and the 1993 Uniform Electrical Code. State law requires the City to adopt these Codes. The Uniform Construction Codes have numerous technical revisions that primarily address changes in technology, building materials, and new construction techniques. By adopting the County Codes by reference, the City will retain specific City and County provisions that have been developed over the years for our geographic area of State and nation. As required by law, a public hearing notice has been published to adopt Ordinance No. 433 by reference. (A publication notice is attached.)

## **RECOMMENDATION:**

Conduct the public hearing; waive further reading and introduce Ordinance No.433 adopting by reference the Los Angeles County Building, Electrical, Plumbing, Mechanical and Fire Codes.

# FISCAL IMPACT:

Fiscal impact will be approximately \$1,000 for the purchase of new books. This cost will be offset by the issuance of permits.
