

ORDINANCE NO. 15

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF  
HAWAIIAN GARDENS ADOPTING A ZONING ORDINANCE

The City Council of the City of Hawaiian Gardens does  
ordain as follows:

SECTION 1. Except as hereinafter provided, the Los Angeles  
County Zoning Ordinance, (Ordinance No. 1494) as adopted and in effect  
on December 8, 1961, is hereby adopted by reference as the Zoning  
Ordinance of the City of Hawaiian Gardens.

SECTION 2. Three copies of said Los Angeles County Zoning  
Ordinance shall remain on file at all times with the City Clerk in  
the City Hall of the City of Hawaiian Gardens.

SECTION 3. Notwithstanding any contrary provision found in  
the aforementioned Los Angeles County Zoning Ordinance, the following  
provisions shall control in the City of Hawaiian Gardens:

A. GARAGING REQUIREMENTS. In residential zones,  
a single family residence must have at least a double garage or car  
port. Two or more units on one parcel shall have at least one and  
one-half garages or car ports per unit. In cases where a fraction  
of a garage or car port is required by the provisions of this section,  
one full additional garage or car port shall be provided. Minimum  
size for a single garage or car port shall be ten feet wide and twenty  
feet long. Minimum size for a double garage or car port shall be  
twenty feet wide and twenty feet long.

Where additional units are constructed on the  
same parcel of land after the effective date of this Ordinance, to-  
gether with existing residential units which were in existence prior  
to the effective date of this Ordinance, sufficient garages or car  
ports must be provided to meet the required parking as set forth in  
this Ordinance, for all of the units including any existing units.

B. SET BACK REQUIREMENTS. All residential zones  
will have a front yard of not less than twenty feet or in the alter-  
native a front yard of not less than the average depth of the front  
yards next adjacent thereto on either side. A vacant lot or a parcel  
of land or a lot or parcel of land having a front yard of more than  
twenty feet shall be considered as having a front yard of twenty feet.

C. SIDE AND REAR YARD REQUIREMENTS. All resi-  
dential zones shall have a rear yard of at least five feet, and a  
side yard of three feet for single story construction on each side;  
a side yard of five feet on each side for construction of two or more  
stories, except that a side yard of three feet will be permitted on  
the side of any construction which has no openings, if any.

D. No dwelling units may be constructed without  
first having or agreeing to install curbs and gutters upon the entire  
frontage of the parcel upon which said units are proposed for con-  
struction. In addition, in any R-3 or R-4 zone, no dwelling units  
may be constructed upon any parcel of land unless said parcel fronts  
upon a dedicated city street, or unless adequate arrangements, satis-  
factory to the City, have been made for the construction and dedication  
of said street and sidewalks.

E. No building shall be constructed within the  
City of Hawaiian Gardens unless adequate provisions, satisfactory to  
the City Engineer, shall have been made to serve said building with  
sewers and water service.

F. In R-3 zones or higher, a minimum of 70  
square feet of contiguous yard, not less than ten feet in width, not  
including any side yard required by this Ordinance, must be provided  
for each residential unit constructed upon any parcel of land in the  
City of Hawaiian Gardens.



G. No auxiliary buildings or other construction, except fences or walls not a part of the building erected upon any parcel of land, shall be permitted in any front, back or side yard required under the provisions of this code.

H. Notwithstanding any provision to the contrary contained in said Los Angeles County Zoning Ordinance, the City Council of the City of Hawaiian Gardens may establish any new or different fee or charge for the processing of any application for a zone exception or zone change by resolution, adopted by said City Council.

I. Notwithstanding any other or different provision contained in the Building Code of the City of Hawaiian Gardens, no building or other existing structure may be relocated within the City of Hawaiian Gardens without first obtaining a permit to be issued by said City Council. Any person who is denied such a permit, or is aggrieved by any provision or condition of such a permit, may obtain a hearing before said City Council by applying for same in writing within thirty days following the date of action by the City Council. In granting any such permit, the City Council may impose any condition thereon which it deems reasonable.

SECTION 4. If any section, sub-section, sentence, clause or phrase of this Ordinance is held to be unconstitutional or invalid, such decision shall not affect the remaining portion of this Ordinance. The City Council hereby declares that it would have passed this Ordinance, and each section and sub-section thereof, irrespective of the fact that any one or more of the sections, sub-sections, sentences, clauses or phrases be declared unconstitutional and invalid.

SECTION 5. This Ordinance shall become effective thirty days from and after the date of its passage. The City Clerk is instructed to post the same in the manner required by law.
