ORDINANCE NO. 6641

AN ORDINANCE AMENDING SECTION 2.60 OF THE LOVELAND MUNICIPAL CODE TO ADD VOTING YOUTH MEMBERS AND UPDATE SECTION 2.60.240 REGARDING THE SENIOR ADVISORY BOARD

WHEREAS, Section 2.60 of the Loveland Municipal Code creates and addresses the City of Loveland's ("City") Boards and Commissions; and

WHEREAS, the Affordable Housing Commission recommends that the City Council amend Loveland Municipal Code Section 2.60.050 to increase the number of Affordable Housing Commission members from nine to ten; and

WHEREAS, that this tenth position on the City's Affordable Housing Commission be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Citizens' Finance Advisory Commission recommends that the City Council amend Loveland Municipal Code Section 2.60.060 to increase the number of Citizens' Finance Advisory Commission members from nine to ten; and

WHEREAS, that this tenth position on the City's Citizens' Finance Advisory Commission be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Community Marketing Commission recommends that the City Council amend Loveland Municipal Code Section 2.60.075 to increase the number of Community Marketing Commission members seven to eight; and

WHEREAS, that this eighth position on the City's Community Marketing Commission be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Construction Advisory Board recommends that the City Council amend Loveland Municipal Code Section 2.60.080 to increase the number of Construction Advisory Board members from nine to ten; and

WHEREAS, that this tenth position on the City's Construction Advisory Board be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Cultural Services Board recommends that the City Council amend Loveland Municipal Code Section 2.60.090 to increase the number of Cultural Services Board members from seven to eight; and

WHEREAS, that this eighth position on the City's Cultural Services Board be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Disabilities Advisory Board recommends that the City Council amend Loveland Municipal Code Section 2.60.100 to increase the number of Disabilities Advisory Board members from 12 to 13; and

WHEREAS, that this 13th position on the City's Disabilities Advisory Board be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Golf Advisory Board recommends that the City Council amend Loveland Municipal Code Section 2.60.120 to increase the number of Golf Advisory Board members from nine to ten; and

WHEREAS, that this tenth position on the City's Golf Advisory Board be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Loveland Utilities Commission recommends that the City Council amend Loveland Municipal Code Section 2.60.180 to increase the number of Loveland Utilities Commission members from nine to ten; and

WHEREAS, that this tenth position on the City's Loveland Utilities Commission be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Open Lands and Trails Advisory Commission recommends that the City Council amend Loveland Municipal Code Section 2.60.190 to increase the number of Open Lands and Trails Advisory Commission members from nine to ten; and

WHEREAS, that this tenth position on the City's Open Lands and Trails Advisory Commission be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Parks and Recreation Commission recommends that the City Council amend Loveland Municipal Code Section 2.60.200 to increase the number of Parks and Recreation Commission members from nine to ten; and

WHEREAS, that this tenth position on the City’s Parks and Recreation Commission be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Police Citizen Advisory Board recommends that the City Council amend Loveland Municipal Code Section 2.60.220 to increase the number of Police Citizen Advisory Board members from nine to ten; and

WHEREAS, that this tenth position on the City’s Police Citizen Advisory Board be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Transportation Advisory Board recommends that the City Council amend Loveland Municipal Code Section 2.60.250 to increase the number of Transportation Advisory Board members from seven to eight; and

WHEREAS, that this eighth position on the City’s Transportation Advisory Board be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Visual Arts Commission recommends that the City Council amend Loveland Municipal Code Section 2.60.260 to increase the number of Visual Arts Commission members from nine to ten; and

WHEREAS, that this tenth position on the City’s Visual Arts Commission be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, the Communications Advisory Board recommends that the City Council amend Loveland Municipal Code Section 2.60.300 to increase the number of Communications Advisory Board members from nine to ten; and

WHEREAS, that this tenth position on the City’s Communications Advisory Board be a youth representative with membership lasting for a period of one year coinciding with the school year; and

WHEREAS, in May 2023, the Senior Advisory Board voted unanimously to amend Section 2.60.240 to allocate an existing membership position to a youth representative with membership lasting for a period of one year coinciding with the school year, change the term length for organization representative members from two to three years, remove several specific organizations and list generally the agency types from which members may be drawn, and update the Commission’s purpose; and

WHEREAS, City Council finds that the addition of youth representatives to certain Boards and Commissions, the allocation of a current membership position to a youth representative on the

Senior Advisory Board, and amendments to Section 2.60.240 regarding the Senior Advisory Board, are in the best interests of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVELAND, COLORADO:

Section 1. That Subsection A of Section 2.60.050 – Affordable Housing Commission – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.050

- A. There is established an affordable housing commission consisting of ten members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be three years.

Section 2. That Subsection A of Section 2.60.060 – Citizens’ Finance Advisory Commission – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.060

- A. There is established a citizens’ finance advisory commission consisting of ten members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be three years.

Section 3. That Subsection A of Section 2.60.075 – Community Marketing Commission – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.075

- A. There is established a community marketing commission consisting of eight members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. Except for the youth member, members on the commission shall have backgrounds in the fields and businesses of lodging, tourism, the arts, marketing, economic development and community development. The term for two of the initial members appointed shall be for one year, two other initial members shall be appointed for a term of two years, and the remaining initial three members shall be

appointed for three-year terms. After these initial terms expire, members shall be appointed for a three-year term.

Section 4. That Subsection A of Section 2.60.080 – Construction Advisory Board – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.080

- A. There is established a construction advisory board consisting of ten members appointed by the City Council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. Except for the youth member, the term of office of each member shall be three years, and members shall have experience in construction, including but not limited to experience in the construction trades or as a professional in the construction industry.

Section 5. That Subsection A of Section 2.60.090 – Cultural Services Board – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.090

- A. There is established a cultural services board consisting of eight members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be four years.

Section 6. That Subsection A of Section 2.60.100 – Disabilities Advisory Commission – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.100

- A. There is established a disabilities advisory commission consisting of 13 members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be three years.

Section 7. That Subsection A of Section 2.60.120 – Golf Advisory Board – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.120

- A. There is established a golf advisory board consisting of ten members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be three years.

Section 8. That Subsection A of Section 2.60.180 – Loveland Utilities Commission – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.180

- A. There is established a Loveland Utilities Commission consisting of ten members appointed by the city council. Any person who is a customer of the city's water, wastewater, or electric utility, or who is an authorized representative of such a customer, shall be eligible for appointment to the commission. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be three years.

Section 9. That Subsection A of Section 2.60.190 – Open Lands and Trails Advisory Commission – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.190

- A. There is established an open lands and trails advisory commission consisting of ten members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be four years. The City shall request the attendance of a non-voting liaison from Larimer County Natural Resources to attend meetings on a regular basis to assure ongoing communications between the city and county.

Section 10. That Subsection A of Section 2.60.200 – Parks and Recreation Commission – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.200

- A. There is established a parks and recreation commission consisting of ten members appointed by the city council. One member shall be a high school student residing within

the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be three years.

Section 11. That Subsection A of Section 2.60.220 – Police Citizen Advisory Board – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.220

- A. There is established a police citizen advisory board consisting of ten members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be three years.

Section 12. That Section 2.60.240 – Senior Advisory Board – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.240

- A. There is established a senior advisory board consisting of fifteen members. Nine members shall be appointed by the city council to serve terms of three years. One of the aforementioned nine members shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. Six additional members shall be appointed by the city council to serve terms of three years. These aforementioned six members shall consist of one member from each of the Chilson Senior Advisory Committee and one member from the Housing Authority of the City of Loveland. The remaining four members shall be affiliated with a local non-profit agency or local health care agency. All fifteen members of the senior advisory board are voting members.
- B. The purpose of the senior advisory board shall be to serve as an advisory body to the city council as to empower and advocate for older adults in the Loveland area to live fulfilling lives. Additionally, the board shall:
 - 1. Facilitate internal and external outreach, education, and general community-wide communication; and
 - 2. Collaborate with other boards and commissions.

Section 13. That Subsection A of Section 2.60.250 – Transportation Advisory Board – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.250

- A. There is established a transportation advisory board consisting of eight members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be three years.

Section 14. That Subsection A of Section 2.60.260 – Visual Arts Commission – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.260

- A. There is established a visual arts commission consisting of ten members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be three years.


Section 15. That Subsection A of Section 2.60.300 – Communications Advisory Board – of the Loveland Municipal Code is hereby amended to read in full as follows:

2.60.300

- A. There is established a communications advisory board consisting of ten members appointed by the city council. One member shall be a high school student residing within the city who shall be under the age of twenty-one at the time of appointment and whose term of office shall be for one year coinciding with the school year and the summer months immediately prior to such school year, provided that such member shall be excused from meeting attendance during school breaks. The term of office of all other members shall be three years.

Section 16. That as provided in City Charter Section 4-9(a)(7), this Ordinance shall be published by title only by the City Clerk after adoption on second reading unless the Ordinance has been amended since first reading in which case the Ordinance shall be published in full or the amendments shall be published in full. This Ordinance shall be in full force and effect (10) days after publication following final adoption, as provided in City Charter Section 4-8(b).




