

ORDINANCE NUMBER 2904

AN ORDINANCE OF THE CITY OF SAPULPA, OKLAHOMA, AMENDING THE SAPULPA CITY CODE, PART 11, PARKS, RECREATION, AND CEMETERY, BY REPEALING AND REPLACING SECTION 11-428; PROVIDING FOR FISHING PERMITTING, RULES AND REGULATIONS BY REPEALING AND REPLACING SAME; AND MASTER FEE SCHEDULE TO THE SAPULPA CITY CODE, APPENDIX A, SECTIONS 11.11-428 PROVIDING FEES FISHING; PROVIDING FOR AN EFFECTIVE DATE, REPEALER, SEVERABILITY, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL, CITY OF SAPULPA, OKLAHOMA:

Section 1. The Sapulpa City Code, Part 11, Parks, Recreation, and Cemetery, is hereby amended by repealing existing Section 11-428 and replacing same with new Section 11-428, which reads in its entirety as follows, to-wit:

"SECTION 11-428. CLASSIFICATION; FEES; PERSONS UNDER EIGHT YEARS OF AGE OR AGE SIXTY-FIVE OR OLDER.

- A. Fishing permits as required by this article shall be of the following three (3) kinds:
1. A Yearly All City Lake Permit, which shall entitle the holder to fish for the period of one (1) year from the date of issuance upon any of the waters designated by Section 11-425;
  2. A Daily All City Lake Permit, which shall entitle the holder to fish until sunrise following the day of issuance thereof; and
  3. Family All City Lake Fishing Permit which shall entitle four specifically named individuals ages 9 or older to fish for the period of one (1) year from the date of issuance upon any of the waters designated by Section 11-425. Additional family members may be added for an additional, per person fee as specified by the Master Fee Schedule.

All City Lake fishing permits shall be sold for such sums as are set by the Master Fee Schedule. Fishing permits shall not be required of persons under the age of eight (8) years; and provided, further, that no fee shall be charged from persons sixty-five (65) years of age or older or upon presentation of state-issued disability permit, provided

these individuals are over eight (8) years of age and they fish only in Lake Sahoma, defined as the water below the Pretty Water waterfall to the Lake Sahoma dam.”

**Section 2.** The Sapulpa City Code, Appendix A, Master Fee Schedule, is hereby amended by repealing existing Section 11.11-428 and replacing same with new Section 11.11-428, which reads in its entirety as follows, to-wit:

**SECTION 11.11-428 FISHING PERMIT FEES.**

The fees referenced in Section 11-428 are as follows:

All City Lake permit:

- \$35.00 (tax included) per year: Ages 17-64.
- \$20.00 (tax included) per year: Ages 9-16 or 65 and older; or  
Upon presentation of state issued disability permit.
- \$5.00 (tax included) daily; 9 years and up, children 8 years and younger fish free.

All City Lake Family Pass:

- \$60.00 (tax included): Covers four specifically named individuals ages 9 and over, plus \$15.00 (tax included) for each additional family member.”

**Section 3.** All ordinances, or parts of ordinances, in conflict with this ordinance are repealed to the extent of conflict only.

**Section 4.** If any part or parts of this ordinance are held invalid or ineffective, the remaining portion shall not be affected but remain in full force and effect.

**Section 5. EMERGENCY.** Being immediately necessary that the provisions of this ordinance be put into full force and effect for the preservation of the public peace, health, and safety of the City of Sapulpa, Oklahoma, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect after its passage, approval, and publication as required by law.
