AN ORDINANCE CLOSING EDITH HENRY LANE
Summary

This Ordinance orders closure as a public way of Edith Henry Lane subject to reservation of existing utility lines and easements.

WHEREAS, DMCGL, LLC has requested closure of Edith Henry Lane, Maysville, Kentucky; and

WHEREAS, the right of way is excess and there is no need to use it as a public way;

The City of Maysville, Kentucky, makes the following Findings of Fact:

- (1) The City of Maysville and DMCGL, LLC are the only property owners adjoining the public way to be closed.
- (2) Written notice of the proposed closing was given to DMCGL, LLC. DMCGL, LLC has given its written notarized consent to the closing of Edith Henry Lane and a copy of the Consent is attached hereto.

NOW THEREFORE, BE IT ORDAINED BY THE CITY MAYSVILLE, KENTUCKY, as follows:

- (1) Edith Henry Lane, Maysville, Kentucky is hereby ordered closed, subject to the reservations hereinafter recited.
- (2) Existing utility lines and easements on, over, through or across portions of the street are hereby reserved as provided in the City of Maysville, Kentucky, Code of Ordinances Section 171.02.
- (3) The Mayor is hereby authorized and directed to execute a deed for one-half of the closed alley way to DMCGL, LLC and the remaining one-half of the closed alley way shall be retained by the City of Maysville.
