AN ORDINANCE OF THE CITY OF EDEN PRAIRIE, MINNESOTA AMENDING CITY CODE CHAPTER 11, SECTION 11.03, SUBDIVISION 2, RELATING TO SIDE YARD SETBACKS IN THE R1-9.5 ZONING DISTRICT; AND ADOPTING BY REFERENCE CITY CODE CHAPTER 1 AND SECTION 11.99 WHICH AMONG OTHER THINGS CONTAIN PENALTY PROVISIONS

THE CITY COUNCIL OF THE CITY OF EDEN PRAIRIE, MINNESOTA ORDAINS:

<u>Section 1.</u> City Code Chapter 11, Section 11.03, Subdivision 2 is hereby amended by deleting subsection A.8 in its entirety.

<u>Section 2.</u> City Code Chapter 11, Section 11.03, Subdivision 2.B is hereby amended by deleting Table 1 in its entirety and replacing it with Table 1 attached hereto as Exhibit A.

<u>Section 3.</u> City Code Chapter 1 entitled "General Provisions and Definitions Applicable to the Entire City Code Including Penalty for Violation" and Section 11.99 entitled "Violation a Misdemeanor" are hereby adopted in their entirety, by reference, as though repeated verbatim herein.

<u>Section 4.</u> This ordinance shall become effective from and after its passage and publication.

Summary: This ordinance amends Chapter 11 by:

- Deleting City Code, Chapter 11, Section 11.03, Subdivision 2 A.8, relating to certain side yard setbacks in the R1-9.5 zoning district.
- Replacing Section 11.03, Subdivision 2.B, Table 1, with a new Table 1 that modifies the minimum side yard setbacks in the in the R1-9.5 zoning district.
