AN ORDINANCE AMENDING CITY CODE CHAPTER 1, SECTION 26, OFFENSES AGAINST STATE LAWS SUBJECT TO FORFEITURE

The Common Council of the City of St Croix Falls do ordain as follows:

SECTION 1

Article 1 Section 26-1 is amended for renumbering as follows:

Sec. 26-1. - Offenses against state laws subject to forfeiture.

The following statutes defining offenses against the peace and good order of the state are adopted by reference to define offenses against the peace and good order of the city, provided the penalty for commission of such offenses hereunder shall be limited to a forfeiture imposed under section 1-14:
