**AN ORDINANCE AMENDING TITLE 3 CHAPTER 7 OF THE CODE OF ORDINANCES FOR
THE VILLAGE OF OSWEGO, KENDALL AND WILL COUNTIES, ILLINOIS**

Liquor License

(Terminate One (1) Class “B-1” Liquor License for NF Grocery Inc d.b.a. 7-Eleven, 2 East Merchants Drive and Add One (1) Class “B-1” Liquor License for AARAV & Arman Inc. d.b.a. 7-Eleven #27099C, 2 East Merchants Drive)

WHEREAS, the Village of Oswego (“Village”) has a population of more than 25,000 and is therefore a “Home Rule Unit” under the 1970 Illinois Constitution; and

WHEREAS, the Illinois Constitution of 1970 provides that a Home Rule Unit may exercise any power and perform any function pertaining to its government and affairs, including but not limited to the power to regulate for the protection of the public health, safety, morals and welfare; to license, to tax; and to incur debt; and

WHEREAS, the Village has in full force and effect a codified set of those ordinances of the Village which are of a general and permanent nature, which said codified set is known and designated as the Village Code of the Village of Oswego, as amended; and

WHEREAS, NF Grocery Inc d.b.a. 7-Eleven located at 2 East Merchants Drive sold the business to AARAV & Arman Inc. d.b.a. 7-Eleven #27099C; and

WHEREAS, AARAV & Arman Inc. d.b.a. 7-Eleven #27099C applied for a Class “B-1” liquor license which authorizes the licensee to sell alcoholic beverages in original packages only for consumption off the premises; and

WHEREAS, all required applications, permits, registrations and licenses shall be obtained from the Village of Oswego, Kendall County, and the State of Illinois prior to release of the Village issued liquor license.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF OSWEGO, KENDALL AND WILL COUNTIES, ILLINOIS IN THE EXERCISE OF THEIR HOME RULE, STATUTORY AND OTHER POWERS, AS FOLLOWS:

Section 1: The recitals set forth above are hereby incorporated by this reference.

Section 2: The Village Clerk, acting as the Secretary of the Local Liquor Commissioner, is directed to revise the number of active liquor licenses, within Section 3-7-11 of the Village Code of the Village of Oswego, to first, decrease the number of Class “B-1” licenses by terminating the license previously issued to NF Grocery Inc d.b.a. 7-Eleven, and thereafter to issue a new Class “B-1” liquor license to AARAV & Arman Inc. d.b.a. 7-Eleven #27099C, effective at such time AARAV & Arman Inc. d.b.a. 7-Eleven #27099C closes on its purchase of the business located at 2 East Merchants Drive, and has otherwise secured a state liquor license, business registration, and has been issued an occupancy permit, and further that AARAV & Arman Inc. d.b.a. 7-Eleven #27099C has qualified for a Village of Oswego Liquor License.

Section 3: SEVERABILITY

This ordinance and every provision thereof shall be considered severable. If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

Section 4: REPEALER

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 5: EFFECTIVE DATE

This Ordinance shall be effective upon its passage, approval, publication in this pamphlet form, which is hereby authorized, as provided by law.
