**ORDINANCE NO. 25 - 47**

**ORDINANCE AMENDING TITLE 3 CHAPTER 7 OF THE OSWEGO MUNICIPAL CODE  
FOR THE VILLAGE OF OSWEGO, KENDALL AND WILL COUNTIES, ILLINOIS**

**Liquor License**

**(NoriOswego LLC d.b.a. Nori Sushi and Grill Located at 2756 U.S. Hwy 34;  
Increase Class D Liquor License)**

**WHEREAS**, the Village of Oswego (“Village”) has a population of more than 25,000 and is therefore a “Home Rule Unit” under the 1970 Illinois Constitution; and

**WHEREAS**, the Illinois Constitution of 1970 provides that a Home Rule Unit may exercise any power and perform any function pertaining to its government and affairs including, but not limited to, the power to regulate for the protection of the public health, safety, morals and welfare; to license; to tax; and to incur debt; and

**WHEREAS**, the Village has in full force and effect a codified set of those ordinances of the Village which are of a general and permanent nature, which said codified set is known and designated as the Oswego Municipal Code, as amended; and

**WHEREAS**, NoriOswego LLC d.b.a. Nori Sushi and Grill applied for a Class D liquor license which allows for the retail sale of beer and wine only for on-premises consumption inside a restaurant. The restaurant must receive more than 50% of its gross revenue from the sale of food; and

**WHEREAS**, all required applications, permits, and licenses shall be obtained from the Village and the State of Illinois prior to release of the Village issued liquor license. NoriOswego LLC d.b.a. Nori Sushi and Grill will also be subject to Food & Beverage taxes; and

**WHEREAS**, based on the foregoing, it is deemed to be in the best interest of the residents and visitors of the Village to amend the Oswego Municipal Code to increase the number of Class D liquor licenses within the Village.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF OSWEGO, KENDALL AND WILL COUNTIES, ILLINOIS**, in the exercise of its home rule powers, as follows:

**Section 1: AMENDMENT TO SECTION 3-7-11**

That the recitals set forth above are incorporated here by reference, and this Ordinance is approved to increase the number of Class D liquor licenses from two (2) to three (3). That Section 3-7-11 of the Oswego Municipal Code is hereby amended as follows:

**3-7-11: NUMBER OF LIQUOR LICENSES**

(A) There shall be no more than the following licenses in effect at any one time:

- There shall be no more than two (2) Class A-1 licenses in effect at any one time.
- There shall be no more than four (4) Class A-2 licenses in effect at any one time.
- There shall be no more than ten (10) Class A-3 licenses in effect at any one time.
- There shall be no more than fifteen (15) Class B-1 licenses in effect at any one time.
- There shall be no more than ten (10) Class B-2 licenses in effect at any one time.

There shall be no more than twenty-one (21) Class C licenses in effect at any one time.  
There shall be no more than three (3) Class D licenses in effect at any one time.  
 There shall be no more than two (2) Class E licenses in effect at any one time.  
 There shall be no more than two (2) Class F-1 licenses in effect at any one time.  
 There shall be no more than one (1) Class F-2 licenses in effect at any one time.  
 There shall be no more than two (2) Class G licenses in effect at any one time.  
 There shall be no more than one (1) Class H license in effect at any one time.  
 There shall be no more than zero (0) Class I license in effect at any one time.  
 There shall be no more than zero (0) Class J license in effect at any one time.  
 There shall be no more than zero (0) Class K license in effect at any one time.  
 There shall be no more than one (1) Class L license in effect at any one time.  
 There shall be no more than zero (0) Class M license in effect at any one time.  
 There shall be no more than zero (0) Class N-1 license in effect at any one time.  
 There shall be no more than one (1) Class N-2 license in effect at any one time.  
 There shall be no more than one (1) Class O license in effect at any one time.  
 There shall be no more than one (1) Class P license in effect at any one time.  
 There shall be no more than zero (0) Class Q-1 license in effect at any one time.  
 There shall be no more than one (1) Class Q-2 license in effect at any one time.  
 There shall be no more than zero (0) Class R license in effect at any one time.  
 There shall be no more than zero (0) Class S-1 license in effect at any one time.

**Section 2: SEVERABILITY**

This Ordinance and every provision thereof shall be considered severable. If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

**Section 3: REPEALER**

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**Section 4: EFFECTIVE DATE**

This Ordinance shall be in full force and effect immediately upon its passage, approval and publication in this pamphlet form which is hereby authorized, as provided by law.
