

ORDINANCE NO. 05-22

AN ORDINANCE OF THE CITY OF OLNEY, TEXAS PROVIDING LOCATIONS FOR STOP SIGN AND YIELD SIGN ADDITIONS ; PROVIDING FOR REPEAL OF ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT; PROVIDING SEVERABILITY; ESTABLISHING AN EFFECTIVE DATE; AND FINDING THE MEETING IN COMPLIANCE WITH THE OPEN MEETINGS ACT.

WHEREAS, the City of Olney, Texas wishes to establish new controlled intersections; and,

WHEREAS, the City Council wishes to bring City ordinance in congruence with the current procedures and capabilities of the City; and,

WHEREAS, the City Council deems it necessary to establish certain guidelines for the new controlled intersections.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF OLNEY, TEXAS:

Section I. Addition

Sec. 12.02.004. Stop Intersections

A. All vehicular traffic shall comply with stop signs placed at the following intersections:

1. While proceeding south on North Avenue A, shall stop at the intersection of Main Street / Hwy 114.
2. While proceeding south on South Avenue D, shall stop at the intersection of Grove Street.
3. While proceeding north on North Avenue D, shall stop at the intersection of Dunagan Street.
4. While proceeding north on North Avenue E, shall stop at the intersection of Dunagan Street.
5. While proceeding north on North Avenue F, shall stop at the intersection of Dunagan Street.
6. While proceeding east on Dunagan Street, shall stop at the intersection of North Avenue C.
7. While proceeding north on North Grand Avenue, shall stop at the intersection of Dunagan Street.
8. While proceeding east on Edwards Street, shall stop at the intersection of North Avenue C.
9. While proceeding west on Elm Street, shall stop at the intersection of Haggard Road.
10. While proceeding west on Highland Road, shall stop at the intersection of Haggard Road.
11. While proceeding west on Gray Street, shall stop at the intersection of Kay Road.

12. While proceeding west on Richmond Street, shall stop at the intersection of Kay Road.
13. While proceeding south on Hillcrest Drive, shall stop at the intersection of West Oak Street.
14. While proceeding south on South Avenue J, shall stop at the intersection of Hamilton Street.
15. While proceeding west on Hunt Street, shall stop at the intersection of South Avenue C.
16. While proceeding west on East York Street, shall stop at the intersection of South Avenue B.
17. While proceeding west on Cherry Street, shall stop at the intersection of South Avenue G.
18. While proceeding west on Church Street, shall stop at the intersection of South Avenue G.
19. While proceeding south on South Grand Avenue, shall stop at the intersection of Church Street.
20. While proceeding north on Bluebonnet Drive, shall stop at the intersection of Grove Street.
21. While proceeding east on Willow Drive, shall stop at the intersection of Mockingbird Lane.
22. While proceeding northwest on Honeysuckle Court, shall stop at the intersection of Woodland Drive.
23. While proceeding east on Mistletoe Lane, shall stop at the intersection of Woodland Drive.
24. While proceeding west on Woodland Drive, shall stop at the intersection of Country Club Lane.
25. While proceeding west on Bankhead Drive, shall stop at the intersection of Country Club Lane.
26. While proceeding west on Fairway Drive, shall stop at the intersection of Country Club Lane.
27. While proceeding west on Chapparral Circle, shall stop at the intersection of Mistletoe Lane.
28. While proceeding east on Elizabeth Street, shall stop at the intersection of Guimarin Street.
29. While proceeding east on West Gray Street, shall stop at the intersection of North Avenue N.
30. While proceeding west on Knox Street, shall stop at the intersection of Guimarin Street.
31. While proceeding north or south on North Avenue B, shall stop at the intersection of Payne Street.
32. While proceeding north or south on North Avenue D, shall stop at the intersection of Gray Street.
33. While proceeding east or west on Gray Street, shall stop at the intersection of North Grand Avenue.
34. While proceeding east or west on Bloodworth Street, shall stop at the intersection of North Avenue C.

35. While proceeding east or west on Howard Street, shall stop at the intersection of North Avenue C.
36. While proceeding east or west on Howard Street, shall stop at the intersection of North Grand Avenue.
37. While proceeding east or west on Payne Street, shall stop at the intersection of North Avenue C.
38. While proceeding east or west on Payne Street, shall stop at the intersection of Hillcrest Street.
39. While proceeding north or south on South Avenue E, shall stop at the intersection of Grove Street.
40. While proceeding north or south on South Avenue E, shall stop at the intersection of Church Street.
41. While proceeding north or south on South Avenue E, shall stop at the intersection of Cherry Street.
42. While proceeding east or west on Thomas Street, shall stop at the intersection of Guimarin Street.
43. While proceeding east or west on West Knox Street, shall stop at the intersection of Mockingbird Lane.
44. While proceeding north or south on North Grand Avenue, shall stop at the intersection of Grove Street.

Sec. 12.02.005. Yield Intersections

B. All vehicles proceeding along the following streets, in the directions respectively stated, shall yield the right-of-way to vehicles on the other street or streets as set forth in this article:

1. While proceeding west on Cactus Lane, shall yield at the intersection of Farmer Avenue.
2. While proceeding west on Gray Street, shall yield at the intersection of North Avenue C.
3. While proceeding west on Gray Street, shall yield at the intersection of North Avenue E.
4. While proceeding west on Hunt Street, shall yield at the intersection of South Avenue B.
5. While proceeding west on Pecan Street, shall yield at the intersection of South Avenue A.
6. While proceeding west on West Gray Street, shall yield at the intersection of North Avenue N.

SECTION II. **Repeal of Ordinances in Conflict**

All ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed.

SECTION III.

Severability

Should any section or part of this ordinance be held unconstitutional, illegal, or invalid, or the application to any person or circumstance for any reasons thereof ineffective or inapplicable, such unconstitutionality, illegality, invalidity, or ineffectiveness of such section or part shall in no way affect, impair or invalidate the remaining portion or portions thereof; but as to such remaining portion or portions, the same shall be and remain in full force and effect and to this end the provisions of this ordinance are declared to be severable.

SECTION IV.

Effective Date

This ordinance shall take effect immediately from and after its final passage and publication in accordance with the provisions of the Charter of the City.

SECTION V.

Open Meetings

It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the Open Meetings Act, *Chapter. 551, Tex. Gov't. Code.*
