

ORDINANCE NO. 46-22

SPONSOR: THE MAYOR

TO REPEAL AND RECREATE THE FIRST PARAGRAPH OF SECTION 1.04 AND SUBSECTION 1.055 3. OF THE CODE OF GENERAL ORDINANCES FOR THE CITY OF KENOSHA REGARDING MAYOR'S AND MUNICIPAL JUDGE'S SALARY

The Common Council of the City of Kenosha, Wisconsin, do ordain as follows:

Section One: The first paragraph of section 1.04 of the Code of General

Ordinances for the City of Kenosha, Wisconsin, is hereby repealed and recreated as follows:

The Mayor shall be elected at the 2004 Spring election for a term of four (4) years, and every four (4) years thereafter. Effective on the third Tuesday in April, 2022, the Mayor shall receive a salary of seven thousand four hundred seventy-seven dollars (\$7,477.00) per month. Effective on the third Tuesday in April, 2023, the Mayor shall receive a salary of seven thousand five hundred eighty-nine dollars (\$7,589.00) per month. Effective on the third Tuesday in April, 2024, the Mayor shall receive a salary of nine thousand, nine hundred sixteen dollars and sixty-six cents (\$9,916.66) per month. Effective on the third Tuesday in April, 2025, the Mayor shall receive a salary of ten thousand, two hundred fourteen dollars and sixteen cents (\$10,214.16) per month. Effective on the third Tuesday in April, 2026, the Mayor shall receive a salary ten thousand, five hundred twenty dollars and fifty-nine cents (\$10,520.59) per month. Effective on the third Tuesday in April, 2027, the Mayor shall receive a salary ten thousand, eight hundred thirty-six dollars and twenty cents (\$10,836.20) per month. The salary shall be paid on the same schedule as provided for nonrepresented employees. The Mayor shall receive the same fringe benefits as Department Heads except for sick leave or vacation accrual; in addition to the fringe benefits described in the previous clause, after completion of a four-year term, a former mayor who initially took office after January 1, 2024, is eligible for the same level of City-provided health insurance available to retired department heads, from the age of 60 years to the eligibility of the former mayor for Medicare benefits from the federal government.

Section Three: Subsection 1.055 3. of the Code of General Ordinances for the

City of Kenosha, Wisconsin, is hereby repealed and recreated as follows:

3. Compensation. The salary for the office of Municipal Judge in lieu of fees or costs shall be seventy thousand six hundred dollars (\$70,600.00) per annum. Effective on the third Tuesday in April, 2023, the Municipal Judge shall receive a salary of seventy-two thousand twelve dollars (\$72,012.00) per annum. Effective on the third Tuesday in April, 2024, the Municipal Judge shall receive a salary of seventy-four thousand, one hundred seventy-two dollars and thirty-six cents (\$74,172.36) per annum. Effective on the third Tuesday in April, 2025, the Municipal Judge shall receive a salary of seventy-six thousand, three hundred ninety-seven dollars and fifty-three cents (\$76,397.53) per annum. Effective on the third Tuesday in April, 2026, the Municipal Judge shall receive a salary of seventy-eight thousand, six hundred eighty-nine dollars and forty-six cents (\$78,689.46) per annum. Effective on the third Tuesday in April, 2027, the Municipal Judge shall receive a salary of eighty-one thousand, fifty dollars

and fourteen cents (\$81,050.14) per annum. No compensation shall be paid to the Judge for any time during his term for which he or she has not executed and filed his or her official bond and oath as required by Subsection 4. No compensation shall be paid for any day for which Court is scheduled to be in session pursuant to G.1. of this Section 1.055 for which the City Municipal Judge is not in attendance except that said Municipal Judge shall be permitted two and one-half (2½) working days off per full calendar month worked which time may be used as sick time vacation time or personal time. Where possible two (2) weeks advance notice of an off day or off days shall be submitted in writing to the City Administrator, the City Attorney and the City Police Chief. The Municipal Judge shall, as a condition precedent to receiving any compensation in the forthcoming month file an Affidavit with the City Treasurer on or before the last working day of each calendar month stating that "No case which has been submitted in final form to him in the past thirty (30) days, exclusive of time of total disability, if any, remains undecided."

Section Three: This Ordinance shall become effective upon passage and publication.
