

ORDINANCE NO. 2023-13

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF JASPER,
INDIANA, ESTABLISHING FEES FOR RENTAL AND ASSOCIATED COSTS
OF THE JASPER ARTS CENTER AND FEES FOR THE
PARTICIPATION IN JASPER ARTS CENTER PROGRAMS**

(Amending Jasper Municipal Code §1.57.025)

WHEREAS, the Common Council of the City of Jasper, Indiana, adopted Ordinance No. 2002-43 establishing fees for rental and associated costs of the Jasper Arts Center and fees for the participation in Jasper Arts Center Programs on September 25, 2002, said ordinance being amended, from time to time;

WHEREAS, the Jasper Community Arts Commission has reviewed the existing schedule of handling fees heretofore fixed by the Jasper Municipal Code and has determined said fees require adjustment in order to adequately reflect the actual cost of providing these services and has recommended to the Common Council that fees be revised;

WHEREAS, the Common Council has also reviewed the schedule of rates and charges and believes that the language contained therein is fair and equitable and based on the actual cost to the city to provide these amenities and services, and the existing language should be repealed and replaced with the language contained herein.

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF
THE CITY OF JASPER, INDIANA, AS FOLLOWS:**

SECTION 1. Section 1.57.025 of the Municipal Code of the City of Jasper, Indiana, be amended by **replacing** the current language with the following language:

(1.57.025) Processing and Handling Fees. The City of Jasper shall charge those persons or entities purchasing tickets for Jasper Community Arts Commission sponsored ticketed events, as follows:

PROCESSING FEES

Phone, Mail-in or Online orders for purchase of tickets.	\$4.00 per order
Walk-in purchases or purchases at the door on the day of performance	No processing fee

SECTION 2. Separability. If any section, sub-section, sentence, clause, phrase or portion of this ordinance shall for any reason be held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions thereunder.

SECTION 3. Prior Ordinances. Any ordinances and/or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. Effective Date. This Ordinance shall be in full force and effect from and after its passage by the Common Council, its approval by the Mayor, and completion of any other legal requirements, all in the manner as provided by law.


