

**AN ORDINANCE AFFIXING SALARIES AND WAGES FOR THE ELECTED  
OFFICIALS AND THE CIVIL CITY EMPLOYEES OF THE CITY OF JASPER,  
INDIANA FOR THE YEAR 2025**

**WHEREAS**, on the 23<sup>rd</sup> day of October, 2024, the Common Council of the City of Jasper, Indiana (“Council”) adopted Ordinance No. 2024-19 (“Salary Ordinance”);

**WHEREAS**, the Jasper City Parks and Recreation Board (“Park Board”) reviewed the salary ordinance and recommended to amend the listed employees within the Department of Parks and Recreation by adding new positions, consistent with the programming being offered by the department;

**WHEREAS**, the Jasper Parks and Recreation Department offers its facilities and equipment for use of programming for the public and specifically offers seasonal camp activities for youth;

**WHEREAS**, the Park Board has recommended amending the “Department of Parks and Recreation Activity Fees” to include fees for a seasonal golf youth camp and a seasonal pickleball youth camp; and

**WHEREAS**, the City of Jasper incurs costs in having these services available for the public and finds that it is necessary and prudent for the financial well-being of the City of Jasper to Establish a fee schedule for these activities and facilities.

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF JASPER, INDIANA, that:**

SECTION 1. Section 1 of Ordinance No. 2024-19 shall be amended by **adding** the following italicized language:

Seasonal:

*Camp Instructor* *\$50 / participant*

**SECTION 2.** All other parts of Ordinance No. 2024-19 shall remain in full force and effect.

**SECTION 3.** Section 1.15.020 of the Municipal Code of the City of Jasper, Indiana (“Code”) shall be amended by **replacing** the existing language for leagues, contained in Exhibit B, immediately after the rates for “PRE-SCHOOL CAMP – KAMP 4 KIDS,” as shown herein:

Fall/Winter CO-ED Volleyball League (per team)	\$80.00
Co-ed Summer Volleyball League (per team)	\$70.00
Cornhole (per team)	\$40.00
Weight training (per participant)	\$100.00

SECTION 4. Section 1.15.020 of the Municipal Code of the City of Jasper, Indiana (“Code”) shall be amended by **adding** the language for “Seasonal Camps,” shown below, immediately following the language regarding “LEAGUES”:

<b>SEASONAL CAMPS</b>	
Youth Golf Camp (per participant)	\$70.00
Youth Pickleball Camp (per participant)	\$70.00


SECTION 5. All other parts of Exhibit B, of Jasper Municipal Code Section 1.15.020 shall remain in full force and effect.


SECTION 6. Separability. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance shall for any reason be held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereunder.


SECTION 7. Prior Ordinances. All ordinances and/or parts of ordinances in conflict herewith are hereby repealed.

SECTION 8. Effective Date. This ordinance shall be in full force and effect from and after its passage by the Common Council, its approval by the Mayor, and completion of any other legal requirements, all in the manner as provided by law.


