

ORDINANCE NO. 2025 - 9
AN ORDINANCE CORRECTING SCRIVENER'S ERROR
CORRECTING FOOTNOTE IN ORDINANCE NO. 2024-17

(Jasper Municipal Code §1.15.020, Exhibit B)

WHEREAS, the City of Jasper incurs costs associated with providing services and facilities to the public and it further finds it necessary and prudent for the financial well-being of the City of Jasper to establish a fee schedule for these services and facilities;

WHEREAS, on October 23, 2024, the Common Council of the City of Jasper, Indiana, adopted Ordinance No. 2024-17, updating and establishing fees for Activities of the Jasper Department of Parks and Recreation;

WHEREAS, Ordinance 2024-17 contained a scrivener's error, specifically failing to include authorization and instruction to include a charge for sales tax on the rental fee for rental of the Jasper Municipal Swimming Pool Party Tent;

WHEREAS, the Indiana State Board of Accounts and the Indiana Department of Revenue requires that sales tax be charged on the rental of tangible personal property to the public; and

WHEREAS, the Common Council desires to correct the Ordinance to reflect the charge and collection of sales tax on party tent rental.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF JASPER, INDIANA, as follows:

SECTION 1. Section 2 of Ordinance 2024-17, the same being Exhibit B to Jasper Municipal Code §1.15.020 "Fees for facility rentals, camps, leagues, boat permits, lot and dock rental, and swimming pool activities," Exhibit B, shall be amended to add footnote reference to taxing information, as follows:


Party Tent Rental 12-3 & 3:30-6:30² \$50.00/3 hrs

SECTION 2. Prior Ordinances. All ordinances and/or parts of ordinances in conflict herewith are hereby repealed.

SECTION 3. Separability. If any section, sub-section, sentence, clause, phrase or portion of this Ordinance shall for any reason be held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereunder.

SECTION 4. Effective Date. This Ordinance shall be in full force and effect from the same effective date as that of the original Ordinance, following its passage by the Common Council, its approval by the Mayor, and completion of any other legal requirements, all in the manner as provided by law.
