

## **ORDINANCE NO. 2532**

**AN ORDINANCE OF THE CITY OF NORTH LAS VEGAS, NEVADA AMENDING CHAPTER 16 OF TITLE 12 OF THE NORTH LAS VEGAS MUNICIPAL CODE BY ADDING A NEW SECTION ENTITLED “USE OF GOLF COURSES” REGARDING THE USE OF THE GOLF COURSE AND LIMITING ACCESS TO GOLF COURSE PLAYERS; AND PROVIDING FOR OTHER MATTERS RELATED THERETO.**

WHEREAS, the City of North Las Vegas currently owns two golf courses: the Community Par 3 Golf Course located at 324 East Brooks in North Las Vegas, and the Aliante Golf Club located at 3100 West Elkhorn in North Las Vegas; and

WHEREAS, the City has engaged a review of its Parks and Recreation area use regulations and has determined such regulations are in need of revision, and modernization in order to meet the needs of the City and its residents;

**THEREFORE, THE CITY COUNCIL OF THE CITY OF NORTH LAS VEGAS DOES ORDAIN:**

**SECTION 1:** The North Las Vegas Municipal Code is hereby amended by adding to the table of contents of Chapter 16 of Title 12 the following:

12.16.045 Access to Golf Course

**SECTION 2:** Chapter 16 of Title 12 of the North Las Vegas Municipal Code is hereby amended by adding a new section hereby designated 045 as follows:

12.16.045 Access to Golf Course

Access to a golf course owned by the City of North Las Vegas shall be limited to registered golfers, the City, its agents and its contractors. The foregoing notwithstanding, the Director of Parks and Recreation may grant access to a golf course to any person for any purpose.

**SECTION 3: NON-INFRINGEMENT OF RIGHTS.** The City Council of the City of North Las Vegas has been informed by the City Attorney as to the constitutionality of this ordinance and based upon such information we are adopting this ordinance in good faith with a reasonable belief that the actions taken by the City of North Las Vegas are not in violation of any rights, privileges or immunities secured by the laws providing for equal rights of citizens or persons.

**SECTION 4: EFFECTIVE DATE.** This ordinance shall become effective after its passage by the City Council of the City of North Las Vegas, and after such passage by the City Council, publication once by title in a newspaper qualified pursuant to the provisions of Chapter 238 of the Nevada Revised Statutes, as amended from time to time.

**SECTION 5: PUBLICATION.** The City Clerk shall cause this ordinance, immediately following its adoption, to be published once by title, together with names of the council members voting for or against passage, in a newspaper qualified pursuant to the provisions of Chapter 238 of the Nevada Revised Statutes, as amended from time to time.
