

## ORDINANCE NO. 2660

**AN ORDINANCE OF THE CITY OF NORTH LAS VEGAS AMENDING TITLE 15 OF THE NORTH LAS VEGAS MUNICIPAL CODE BY REPEALING THE EXISTING CHAPTER 15.16 OF THE MUNICIPAL CODE, BEING THE 2009 EDITION OF THE UNIFORM PLUMBING CODE WITH AMENDMENTS AND ORDINANCE NO. 2564, AND BY ADOPTING THE UNIFORM PLUMBING CODE, 2012 EDITION, WITH THE SOUTHERN NEVADA AMENDMENTS TO THE 2012 UNIFORM PLUMBING CODE, WHICH CONFORM SAID PLUMBING CODE TO SOUTHERN NEVADA PRACTICES; PROVIDING PENALTIES FOR THE VIOLATION THEREOF; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO.**

**THE CITY COUNCIL OF THE CITY OF NORTH LAS VEGAS, NEVADA, DOES ORDAIN:**

**SECTION 1:** Ordinance No. 2564 and Chapter 15.16 of Title 15 of the North Las Vegas Municipal Code, being the 2009 Uniform Plumbing Code with amendments, are hereby repealed.

**SECTION 2:** Title 15 of the North Las Vegas Municipal Code is hereby amended by addition of a new chapter, designated as Chapter 15.08, which shall read as follows:

**15.16.010 Adoption.**

- A. That certain document, three (3) copies of which are on file in the office of the City Clerk of the City of North Las Vegas, Nevada, which is marked and designated as the "Uniform Plumbing Code, 2012 Edition," published by the International Association of Plumbing and Mechanical Officials, together with all tables of contents, definitions, sections, tables, indexes, examples and appendices, is hereby adopted and made a part of this chapter, the same as if it were fully set forth herein, except as amended by the "Southern Nevada Amendments to the 2012 Uniform Plumbing Code".
- B. That certain document, three (3) copies of which are on file in the office of the City Clerk of the City of North Las Vegas, Nevada, which is marked and designated as the "Southern Nevada Amendments to the 2012 Uniform Plumbing Code", by Clark County, the City of North Las Vegas, the City of Las Vegas, Boulder City, the City of Mesquite, the City of Henderson, Pahrump Regional Planning District, and the Clark County School District and is hereby adopted and made a part of this chapter, the same as if it were fully set forth herein.

**SECTION 3: NON-INFRINGEMENT OF RIGHTS.** The City Council of the City of North Las Vegas has been informed by the City Attorney as to the constitutionality of this ordinance and based upon such information we are adopting this ordinance in good faith with a reasonable belief that the actions taken by the City of North Las Vegas are not in violation of any rights, privileges or immunities secured by the laws providing for equal rights of citizens or persons.

**SECTION 4: EFFECTIVE DATE.** This ordinance shall become effective after its passage by the City Council of the City of North Las Vegas, and after such passage by the City Council, publication once by title in a newspaper qualified pursuant to the provisions of Chapter 238 of the Nevada Revised Statutes, as amended from time to time.

**SECTION 5: PUBLICATION.** The City Clerk shall cause this ordinance, immediately following its adoption, to be published once by title, together with names of the council members voting for or against passage, in a newspaper qualified pursuant to the provisions of Chapter 238 of the Nevada Revised Statutes, as amended from time to time.
