ORDINANCE NO. 2683, AS AMENDED

AN ORDINANCE OF THE CITY OF NORTH LAS VEGAS AMENDING ORDINANCE NOS. 1747 AND 2602: AMENDING TITLE 5 OF THE NORTH LAS VEGAS MUNICIPAL CODE (BUSINESS LICENSES AND REGULATIONS); AMENDING SECTION 5.02.040 (SEMI-ANNUAL LICENSES); AMENDING SECTION 5.02.100 (SCHEDULE OF OTHER LICENSE FEES **BUSINESSES**): REPEALING SECTIONS THROUGH 5.02.310 (A - W LICENSE FEES) AND REPLACING WITH NEW SECTIONS 5.02.110 THROUGH 5.02.310 (A - W LICENSE FEES), PROVIDING FOR THE ISSUANCE OF ANNUAL LICENSE FEES AND ASSESSING NEW ANNUAL LICENSE FEES TO REAL ESTATE PROFESSIONALS; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATED THERETO.

THE CITY COUNCIL OF THE CITY OF NORTH LAS VEGAS, NEVADA, DOES ORDAIN:

SECTION 1: Title 5, Chapter 5.02, Subsection 5.02.040 Semi-annual licenses, is hereby re-titled as Subsection 5.02.040, **Annual and semi-annual licenses.**

SECTION 2: Title 5, Chapter 5.02, Subsection 5.02.040 Annual and semi-annual licenses, is hereby amended as follows:

A. Other than license fees based on gross sales and license fees specified for multi-jurisdictional licenses and trucking business licenses, all license fees hereinafter specified in this title, shall be due and payable annually on the last day of September of each year, or semi-annually on the last day of March and the last day of September of each year.

SECTION 3: Title 5, Chapter 5.02, Subsection 5.02.100 Schedule of other license fees and businesses, is hereby amended as follows:

Each person doing business in the city in the categories set forth in the remaining sections of this chapter shall pay to the department in advance, an annual or semi-annual license fee at the rate set forth in the respective categories.

SECTION 4: Title 5, Chapter 5.02, Subsection 5.02.110 A-License fees, is hereby repealed and replaced with the following:

Abstract or title company. For each abstract or title company doing business, or maintaining an agency, six hundred dollars (\$600.00) annually.

Accountant. For each certified public accountant or independent public accountant, one hundred fifty dollars (\$150.00) annually.

Adobe block manufacturing plant. (See Brick yard.)

Adult care home. For each facility with not more than six beds, one hundred dollars (\$100.00) annually. An application for a business license can be issued only upon compliance with all requirements of state regulatory authorities. (Facilities of this kind are regulated and licensed by the Health Division of the Nevada State Department of Human Resources.)

Advertising business. For each advertising business or advertising counsel, two hundred dollars (\$200.00) annually.

Advertising—distributing handbills, etc. For each business distributor advertising samples, handbills, dodgers or printed matter of any kind, one hundred dollars (\$100.00) annually.

Advertising samples. (See Advertising—distributing handbills, etc.)

Advertising signs—electrical. (See Advertising space—leasing or selling.)

Advertising space—leasing or selling. For each lessor or seller of outdoor advertising space, whether billboard or electrical signs, six hundred dollars (\$600.00) annually.

Amusement park. Each amusement park charging admission to the grounds thereof shall pay a fee based upon its gross sales, in accordance with Section 5.02.080 of this chapter.

Arcade. For each arcade, one hundred dollars (\$100.00) annually, and fifty dollars (\$50.00) for each amusement machine and pool table.

Architect. For each architect, one hundred fifty dollars (\$150.00) annually.

Assayer. For each assayer, one hundred fifty dollars (\$150.00) annually.

Astrologer or similar occupation. For each person who conducts, practices or professes to practice the business of astrology, augury, cartomancy, clair-audience, clairvoyance, crystal gazing, divination, fortune telling, hypnotism, life reading, magic, mediumship, necromancy, palmistry, phrenology or prophecy, and demands or receives a fee for the exercise or exhibition of his art, directly or indirectly, or incidental to the conduct of any other business, either as a gift, donation or otherwise, or who gives an exhibition thereof at any place where an admission fee is charged, one thousand dollars (\$1,000.00) annually.

No person may receive a license as an astrologer or similar occupation without first obtaining from the police department a work permit and paying to the director a police investigation fee of fifty dollars (\$50.00).

Auto court. (See Hotels, Section 5.02.180.)

Auctioneer. For each auctioneer, five hundred dollars (\$500.00) annually.

Automobile reclaiming agency. For each automobile reclaiming agency, one hundred dollars (\$100.00) annually.

Automobile wrecking yard. (See Junk yard.)

SECTION 4: Title 5, Chapter 5.02, Subsection 5.02.120 B-License fees, is hereby repealed and replaced with the following:

Bail bond broker. For each bail bond broker or bail bond brokerage business, one hundred fifty dollars (\$150.00) annually.

Banks. For each bank, one thousand dollars (\$1,000.00) annually.

Barber shop. For each barber shop, seventy dollars (\$70.00) annually for the first barber chair, and twenty dollars (\$20.00) annually for each additional barber chair.

Beauty parlor. (See Hairdressing parlor.) For each beauty parlor whether operated in connection with a barbershop or separately, and after securing a state license to do business, seventy dollars (\$70.00) annually for the first operator and twenty dollars (\$20.00) annually for each additional operator.

Billboards. (See Advertising space—leasing or selling.)

Billiard hall. For each billiard hall or billiard room, or pool hall or poolroom, one hundred dollars (\$100.00) annually, and fifty dollars (\$50.00) annually for each billiard table or pool table.

Bookkeeper. (See Accountant.)

Bootblack stand. For each bootblack stand, fifty dollars (\$50.00) annually.

Bowling alley. For each bowling alley, fifty dollars (\$50.00) annually for the first alley and twenty five dollars (\$25.00) annually for each additional alley.

Brokerage establishment. For each brokerage establishment, one hundred twenty dollars (\$120.00) annually.

Builders. (See Contractors.)

Bus. One hundred dollars (\$100.00) fixed annual fee each.

Business college. (See Trade college.)

Business consultant. For each business consultant agency or individual business consultant, one hundred dollars (\$100.00) annually.

SECTION 5: Title 5, Chapter 5.02, Subsection 5.02.130 C-License fees, is hereby repealed and replaced with the following:

Canvassers. (See Solicitors, Section 5.02.270.)

Carnival. (See Traveling shows, Section 5.02.280.)

Check cashing and financial services. Each check cashing and financial services business shall pay an annual fee of five hundred dollars (\$500.00). This includes services licensed pursuant to NRS 604A, as may be amended or renumbered.

Child care. (See <u>Chapter 5.14</u>, Child Care Facilities)

Chiropodist. For each chiropodist, two hundred dollars (\$200.00) annually.

Chiropractor. For each chiropractor, whether as a sole practitioner or as a member or employee of a firm, one hundred fifty dollars (\$150.00) annually.

Christmas tree sales. (See Chapter 5.44, Seasonal Businesses)

Circus. (See Traveling shows, <u>Section 5.02.280</u>.)

Clairvoyant. (See Astrologer, <u>Section 5.02.110</u>.)

Coin-operated amusement machines. (See <u>Chapter 5.06</u>, Amusement Machines and Vending Machines)

Collection agency. Each collection agency licensed pursuant to NRS 649, as may be amended or renumbered, shall pay an annual fee of two hundred seventy five dollars (\$275.00).

Contractor. Each person required to have a state contractor's license pursuant to NRS 624 shall pay a semi-annual fee of one hundred dollars (\$100.00).

Convention, banquet or reception hall. Each convention, banquet or reception hall shall pay an annual fee in accordance with the following schedule:

Courier. Each courier shall pay an annual fee of one hundred dollars (\$100.00).

Credit bureau. Each credit bureau shall pay an annual fee of two hundred dollars (\$200.00).

SECTION 6: Title 5, Chapter 5.02, Subsection 5.02.140 D-License fees, is hereby repealed and replaced with the following:

Dealers in bankrupt, assigned or damaged stock of goods, etc. For each person who ships into and sells in the city any bankrupt, assigned or damaged stock of goods, or other commodities, merchandise or products, including without limitation trucks, construction equipment, and other related items, twelve hundred dollars (\$1,200.00) annually.

Dealers in gasoline, motor fuels, heating oils, or lubricating oil. For each person who sells or distributes gasoline, motor fuel oil of any kind, heating oils or lubricating oil of any kind in bulk, two hundred dollars (\$200.00) annually.

Dentist. For each dentist practicing by himself, or connected with or as a member of a firm, one hundred fifty dollars (\$150.00) annually.

Detective agency. For each private detective agency, bureau or business, two hundred dollars (\$200.00) annually.

Drugless practitioner. For each drugless practitioner, one hundred dollars (\$100.00) annually. This subdivision shall not apply to persons who treat the sick through prayer or spiritual means.

SECTION 6: Title 5, Chapter 5.02, Subsection 5.02.150 E-License fees, is hereby repealed and replaced with the following:

Engineer. For each engineer, practicing as a member of a firm or alone, two hundred dollars (\$200.00) annually.

SECTION 7: Title 5, Chapter 5.02, Subsection 5.02.160 F-License fees, is hereby repealed and replaced with the following:

Finance company. For each finance company, five hundred dollars (\$500.00) annually. For the purpose of this subdivision, a "finance company" means any person other than a bank, who makes a business of lending to others for profit and who holds himself out to the general public as such.

Firearm safety training. One hundred fifty dollars (\$150.00) fixed annual fee.

Fireworks. For each location, fifty dollars (\$50.00).

No person may sell fireworks as a retailer except as a representative of a recognized non-profit organization.

Applications for a fireworks permit must be received on or before the second Tuesday in May and include the following:

1. A copy of the organization's charter;

A letter from the property owner on which the fireworks booth will be located permitting the organization to operate the fireworks booth;

- 3. A certificate or policy of liability insurance in an amount no less than one hundred thousand dollars (\$100,000.00);
- 4. A cleanup deposit fee of fifty dollars (\$50.00), which is refundable; provided, that the business premises has been cleaned up in accordance with the applicable city code.

Fortuneteller. (See Astrologer or similar occupation.)

SECTION 8: Title 5, Chapter 5.02, Subsection 5.02.170 G-License fees, is hereby repealed and replaced with the following:

Gasoline. (See Dealers in gasoline, motor fuel, heating oils, lubricating oil.)

Gunsmith. Each gunsmith shall pay a fee based upon its gross sales, in accordance with Section 5.02.080 of this chapter.

SECTION 9: Title 5, Chapter 5.02, Subsection 5.02.180 H-License fees, is hereby repealed and replaced with the following:

Handbills. (See Advertising—distributing handbills, etc.)

Hippodrome. (See Traveling shows.)

Home health care. For each home health care facility, one hundred dollars (\$100.00) annually; (See Nurses.)

Hotels—Motels. For each hotel, motel, as defined hereunder:

From four to eight guest rooms, Fifty dollars (\$50.00) annually; From nine to eighteen (18) guest rooms, seventy five dollars (\$75.00) annually;

From nineteen (19) to thirty (30) guest rooms, one hundred dollars (\$100.00) annually;

From thirty-one (31) to fifty (50) guest rooms, one hundred fifty dollars (\$150.00) annually;

From fifty-one (51) to eighty (80) guest rooms, two hundred dollars (\$200.00) annually;

From eighty-one (81) to one hundred twenty (120) guest rooms, two hundred fifty dollars (\$250.00) annually;

From one hundred twenty-one (121) rooms or more, three hundred dollars (\$300.00) annually, plus one dollar (\$1.00) per room for more than one hundred twenty-one (121) rooms.

For purposes of this chapter, "hotel" means an establishment that provides for members of the general public temporary lodging and usually meals and other services for paying guests; and "motel" means an

establishment that provides for members of the general public temporary lodging, with or without meals or other services, for motorists in rooms that usually have direct access to an open parking area.

House moving. For each house moving business, one hundred dollars (\$100.00) annually. The licensee shall also obtain and thereafter maintain a bond in the penal sum of fifty thousand dollars (\$50,000.00) executed by a surety company authorized to do business in the state for the then-current year, indemnifying the city against damage to public property, including pavement, and private persons against injury or damage to their property occurring while a house is being moved anywhere within the city. In the event of a recovery against the bond by the city or any private person, the bond shall be restored immediately to the penal sum of fifty thousand dollars (\$50,000.00).

House wrecking. (See Contractors.)

SECTION 10: Title 5, Chapter 5.02, Subsection 5.02.190 I-License fees, is hereby repealed and replaced with the following:

Ice cream vendors—mobile. (See Vendors—mobile.)

Income tax preparer. (See Accountant.)

Insurance adjuster/agency. For each insurance adjuster or insurance adjusting agency, one hundred fifty dollars (\$150.00) annually. This subdivision shall not apply to insurance agents who, as salaried employees of insurance carriers, adjust losses for their employers.

Insurance agent. For each insurance agent, one hundred fifty dollars (\$150.00) annually.

Intelligence office. For each intelligence office, one hundred dollars (\$100.00) annually.

Interior decorator. For each interior decorator, one hundred fifty dollars (\$150.00) annually.

SECTION 11: Title 5, Chapter 5.02, Subsection 5.02.200 J-License fees, is hereby repealed and replaced with the following:

Juke boxes. For each coin-operated juke box, telephone juke box or any other type of coin-operated music reproduction machine or device operated or maintained in any establishment for use by the patrons of

such establishment, fifty dollars (\$50.00) annually for each machine or device.

Junk yard. For each junk yard, two hundred dollars (\$200.00) annually. "Junk yard" means a business for the purchase, sale or resale of old metals, bottles, rags, rubber, paper and all other kinds of material, discarded articles of little value or scrap of any kind.

SECTION 11: Title 5, Chapter 5.02, Subsection 5.02.210 L-License fees, is hereby repealed and replaced with the following:

Land survey services. One hundred seventy dollars (\$170.00) annually.

Lawn maintenance. For each lawn maintenance business, one hundred dollars (\$100.00) annually.

Lawyers. For each lawyer, whether or not connected with or as a member of a firm or practicing alone, two hundred dollars (\$200.00) annually.

Locksmith. For each locksmith, a two hundred fifty dollar (\$250.00) annual fixed license fee. All applicants for a locksmith's license shall be subject to a police investigation and an accompanying fee of fifty dollars (\$50.00).

SECTION 12: Title 5, Chapter 5.02, Subsection 5.02.220 M-License fees, is hereby repealed and replaced with the following:

Manicurist. For each manicurist, fifty dollars (\$50.00) annually.

Menagerie. (See Traveling shows.)

Mercantile. (See Collection agency.)

Miscellaneous flat fee. One hundred dollars (\$100.00) fixed annual fee.

Mobile home park and recreational vehicle park. Each mobile home park or recreational vehicle park shall pay annual license fees as follows:

101 or more	\$3.00 per space

The fees set forth above shall apply whether the spaces are occupied or vacant.

Mobile vendors. (See Vendors—mobile.)

Mortgage and investment. Six hundred seventy-five dollars (\$675.00) fixed annual fee.

Motels. (See Hotels.)

SECTION 13: Title 5, Chapter 5.02, Subsection 5.02.230 N-License fees, is hereby repealed and replaced with the following:

Natatorium. (See Swimming pool.)

Nurses. For each private nurse, one hundred dollars (\$100.00) annually.

Nurseries—child care home. (See <u>Chapter 5.14</u>.) An application for a business license may be issued only upon compliance with all requirements of state regulatory authorities. (Child care nurseries or commercial child care nurseries for five children or more are regulated and licensed by State Bureau of Services for Child Care under NRS 432A.)

SECTION 14: Title 5, Chapter 5.02, Subsection 5.02.240 O-License fees, is hereby repealed and replaced with the following:

Oculist. (See Optometrist.)

Optician. One hundred fifty dollars (\$150.00) annually.

Optometrist. For each optometrist or oculist, one hundred fifty dollars (\$150.00) annually.

Osteopath. For each osteopath, one hundred fifty dollars (\$150.00) annually.

Outdoor advertising. (See Advertising space—leasing or selling.)

SECTION 15: Title 5, Chapter 5.02, Subsection 5.02.250 P-License fees, is hereby repealed and replaced with the following:

Palmist. (See Astrologer.)

Paralegal. Each paralegal shall pay a fee based upon the gross sales, in accordance with <u>Section 5.02.080</u> of this chapter.

Parking lot. For the operation of a public or semipublic parking lot where charges or fees are made for parking, fees shall be in accordance with the following schedule of capacities:

Pawnbroker. For each pawnbroker, eight hundred dollars (\$800.00) annually.

Personal fitness trainer. One hundred dollars (\$100.00) annually.

Phrenologist. (See Astrologer.)

Physician. For each physician, whether as a sole practitioner or as a member or employee of a firm, two hundred twenty five dollars (\$225.00) annually.

Physician assistant. One hundred dollars (\$100.00) annually.

Poolroom. (See Billiard hall.)

Private detective/agency. For each private detective or detective agency, two hundred dollars (\$200.00) annually.

Process server. For each process server, two hundred dollars (\$200.00) annually.

Professional promoter. For each professional promoter, two hundred dollars (\$200.00) annually.

Property management. Two hundred dollars (\$200.00) annually.

Psychiatrist. Two hundred dollars (\$200.00) annually.

Psychologist. Two hundred dollars (\$200.00) annually.

Public payphone company. Each public payphone company shall pay a fee based upon the gross sales, in accordance with <u>Section</u> <u>5.02.080</u> of this chapter.

Public stenographer. (See Stenographer—public.)

SECTION 16: Title 5, Chapter 5.02, Subsection 5.02.260 R-License fees, is hereby repealed and replaced with the following:

Race horse book, distributing information. (See Gaming Ordinance.)

Real estate agent. For each real estate agent, one hundred fifty dollars (\$150.00) annually.

Real estate agency / broker. For each real estate agency / broker, two hundred dollars (\$200.00) annually.

Recovery bureau. One hundred dollars (\$100.00) annually.

Recreational vehicle parks. (See Mobile home park.)

Rental agency. One hundred dollars (\$100.00) annually.

Rental property. Every person who rents to tenants residential housing or rental units shall pay annual fees in accordance with the following schedule of rental units:

The license fees of a licensee who rents to tenants residential rental units at more than one location may be based upon the total number of units added together from all locations.

Reporters, court and convention. For each reporter, one hundred fifty dollars (\$150.00) annually.

Rooming house. (See Hotels.)

Room registry business. For each room registry business, one hundred dollars (\$100.00) annually.

SECTION 17: Title 5, Chapter 5.02, Subsection 5.02.270 S-License fees, is hereby repealed and replaced with the following:

Salvage yard. (See Junk yard.) Two hundred dollars (\$200.00) annually.

Savings and loan association. (See Finance company.)

School nurseries. (See Nurseries—child care facilities.)

Schools. (See Trade schools.)

Seasonal business. For each seasonal business location, fifty dollars (\$50.00) permit fee and fifty dollars (\$50.00) cleanup deposit fee required.

Secondhand dealers. For each secondhand dealer, three hundred dollars (\$300.00) annually.

Shoe shining stand. (See Bootblack stands.)

Signs-electrical. (See Advertising space—leasing or selling.)

Skating rink-traveling. (See Traveling shows.)

Solicitor. For each solicitor, two hundred dollars (\$200.00) annually.

Stenographer—public. (See Reporter, court and convention.)

Storage facilities. For each storage facility that rents or leases individual storage units on a time-period basis:

- A. Fifty dollars (\$50.00) annually for the first storage unit and ten dollars (\$10.00) annually for each additional storage unit; provided, however, that individual storage units do not exceed four hundred (400) square feet.
- B. For all individual storage units of more than four hundred (400) square feet but less than one thousand (1,000) square feet, one hundred dollars (\$100.00) annually for the first storage unit plus twenty dollars (\$20.00) for each additional storage unit.
- C. For all individual storage units of more than one thousand (1,000) square feet or more, license fees shall be based upon a flat rate of four cents per measured square foot annually.

Surgeon. (See Physicians.)

Surveyor. For each surveyor, one hundred fifty dollars (\$150.00) annually.

SECTION 18: Title 5, Chapter 5.02, Subsection 5.02.280 T-License fees, is hereby repealed and replaced with the following:

Tanning salon. Each tanning salon shall pay a fee based upon the gross sales, in accordance with Section 5.02.080 of this chapter.

Tattoo shop. Three hundred dollars (\$300.00) annually.

Taxicab. For each taxicab, one hundred dollars (\$100.00) annually.

Telephone juke boxes. (See Juke boxes.)

Title company. For each title company, six hundred dollars (\$600.00) annually.

Trade college. For each trade college, trade school or business college, where instructions are given in any trade or occupation for which a fee is charged, one hundred eighty dollars (\$180.00) annually.

Trade school. (See Trade college.)

Trailer park. (See Mobile home parks.)

Transportation (limo). One hundred dollars (\$100.00) annually.

Travel agency. One hundred dollars (\$100.00) annually.

Traveling shows. For each proprietor, lessee, or manager of any traveling show, traveling skating rink, circus, hippodrome, menagerie, or carnival intending to exhibit in the open air or under a tent, in any public hall, club room, assembly hall or theater, where movable scenery and theatrical appliances may be used for any performance or exhibition, one hundred dollars (\$100.00) each day, and, upon payment therefor, the director shall issue a permit for the day or number of days so paid. In addition, the proprietor, lessee or manager of any traveling show, traveling skating rink, circus, hippodrome, menagerie or carnival shall pay to the director a two hundred dollar (\$200.00) cleanup deposit which deposit shall be refunded to the holder of the permit, provided the business premises has been cleaned up in accordance with the city code.

Tree toppers. For each tree topper, one hundred fifty dollars (\$150.00) annually. Tree toppers digging up or removing tree stumps shall require a state license.

Trucking business. For each person not classified as a contractor, having a business location outside the city, who for hire, operates a truck or fleet of trucks that enters the city to receive merchandise for delivery outside the city, or to bring merchandise into the city, twenty-five dollars (\$25.00) semi-annually for the first truck so operated, and twelve dollars and fifty cents (\$12.50) semi-annually for each additional truck operated within the city. This fee applies to any person having a fixed or no fixed place of business and who transacts business within the city by receiving or picking up property upon which repairs, personal service or work of any kind may be done for hire outside the city, and by delivering the same to

the owner within the city. This subsection is not intended to apply, however, to trucks engaged in interstate commerce.

SECTION 19: Title 5, Chapter 5.02, Subsection 5.02.290 U-License fees, is hereby repealed and replaced with the following:

Reserved.

SECTION 20: Title 5, Chapter 5.02, Subsection 5.02.300 V-License fees, is hereby repealed and replaced with the following:

Vending machines. (See Chapter 5.06.)

Vendors—mobile. For each person selling or soliciting business for the sale of edible foods from a motorized vehicle approved by the Clark County health department, sixty dollars (\$60.00) annually.

Veterinarian. Two hundred dollars (\$200.00) annually.

<u>SECTION 21</u>: NON-INFRINGEMENT OF RIGHTS. The City Council of the City of North Las Vegas has been informed by the City Attorney as to the constitutionality of this ordinance and based upon such information we are adopting this ordinance in good faith with a reasonable belief that the actions taken by the City of North Las Vegas are not in violation of any rights, privileges or immunities secured by the laws providing for equal rights of citizens or persons.

<u>SECTION 22</u>: EFFECTIVE DATE. This ordinance shall become effective November 19, 2014 after its passage by the City Council of the City of North Las Vegas, and after such passage by the City Council, publication once by title in a newspaper qualified pursuant to the provisions of Chapter 238 of the Nevada Revised Statutes, as amended from time to time.

<u>SECTION 23</u>: **PUBLICATION.** The City Clerk shall cause this ordinance, immediately following its adoption, to be published once by title, together with names of the council members voting for or against passage, in a newspaper qualified pursuant to the provisions of Chapter 238 of the Nevada Revised Statutes, as amended from time to time.
