ORDINANCE NO. 2806

AN ORDINANCE OF THE CITY OF NORTH LAS VEGAS TO AMEND SECTION 13.08.050 OF THE NORTH LAS VEGAS MUNICIPAL CODE TO MODIFY LANDSCAPING WATERING RESTRICTIONS AND PROVIDE FOR OTHER MATTERS PROPERLY RELATED THERETO.

THE CITY COUNCIL OF THE CITY OF NORTH LAS VEGAS, NEVADA, DOES ORDAIN:

SECTION 1: Section 13.08.050, paragraph A of Title 13 shall be amended as follows:

A. As a water conservation measure, from May 1 until August 31 of each calendar year from the hours of 11:00 a.m. until 7:00 p.m., it is unlawful for any customer of a public water system to use water within the water service area of the city for the purpose of irrigation, regardless of method, of turf, gardens, trees, grass, shrubbery, or other vegetation, except as otherwise provided in Section 13.08.050(C) of this chapter.

SECTION 2: Table 13.08.050A located in Section 13.08.050, paragraph B of Title 13 shall be amended as follows:

Months		Watering Days
Winter	(November—February)	Once per Week*
Spring	(March—April)	Three Days per Week*
Summer	(May—August)	Any Day except Sunday
Fall	(September—October)	Three Days per Week*

SECTION 3: NON-INFRINGEMENT OF RIGHTS. The City Council of the City of North Las Vegas has been informed by the City Attorney as to the constitutionality of this ordinance and based upon such information we are adopting this ordinance in good faith with a reasonable belief that the actions taken by the City of North Las Vegas are not in violation of any rights, privileges or immunities secured by the laws providing for equal rights of citizens or persons.

SECTION 4: SEVERABILITY. If any section, paragraph, clause or provision of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause, or provision shall in no way affect the validity and enforceability of the remaining provisions of this Ordinance.

<u>SECTION 5</u>: EFFECTIVE DATE. This Ordinance shall become effective after its passage by the City Council of the City of North Las Vegas and, after such passage by the City Council, publication once by title in a newspaper qualified pursuant to the provisions of Chapter 238 of NRS, as amended from time to time.

<u>SECTION 6</u>: PUBLICATION. The City Clerk shall cause this Ordinance, immediately following its adoption, to be published once by title, together with the names of the Councilmen voting for or against passage, in a newspaper qualified pursuant to the provisions of Chapter 238 of NRS, as amended from time to time.
