

## ORDINANCE NO. 952

AN ORDINANCE TO AMEND CERTAIN PORTIONS OF TITLE 15, CHAPTER "15.04 BUILDING CODE ADOPTED", IN ORDER TO ESTABLISH FEE FOR BUILDING PERMIT.

**WHEREAS**, Chapter 15.04 of the Burlington Municipal Code entitled "Building Code Adopted", should be amended in order to include new rates for building permit fees;

**NOW, THEREFORE, THE COUNCIL OF THE CITY OF BURLINGTON, COLORADO, ORDAINS:**

**SECTION 1. Chapter 15.04 Building Code Adopted, Section 15.04.020 Fee for building permit** is hereby amended to read: At the time of filing an application for building permit, the applicant shall pay a permit fee based on total valuation of the construction or building project as determined by the following fee structure:

Total Valuation	Fee
\$1 - \$500	\$25
\$501 - \$2,000	\$25 for first \$500 plus \$3.00 for each additional \$100, or fraction thereof, to and including \$2,000
\$2,001 - \$40,000	\$70 for first \$2,000 plus \$10.00 for each additional \$1,000, or fraction thereof, to and including \$40,000
\$40,001 - \$100,000	\$450 for first \$40,000 plus \$8.00 for each additional \$1,000, or fraction thereof, to and including \$100,000
\$100,000 - \$500,000	\$930 for first \$100,000 plus \$6.00 for each additional \$1,000, or fraction thereof, to and including \$500,000
\$500,000 - \$1,000,000	\$1,170 for first \$500,000 plus \$5.00 for each additional \$1,000, or fraction thereof, to and including \$1,000,000
\$1,000,000 - \$5,000,000	\$3,670 for first \$1,000,000 plus \$3.00 for each additional \$1,000, or fraction thereof, to and including \$5,000,000
\$5,000,000 and up	\$15,670 for first \$5,000,000 plus \$1.00 for each additional \$1,000, or fraction thereof

Builder pays actual costs for use of outside consultants for plan check and inspections

## SECTION 2.

This Ordinance, immediately upon its passage, shall be recorded in the Book of Ordinances of the City of Burlington, Colorado, authenticated by signature of the Mayor and attested by the Clerk under the corporate seal of the City and shall be


published within the corporate limits of the City of Burlington and the County of Kit Carson and the State of Colorado and shall be in full force and effect thirty days after such publication.
