**AN ORDINANCE APPROVING MEMBERSHIP IN THE ILLINOIS
MUNICIPAL LEAGUE RISK MANAGEMENT ASSOCIATION AND
AUTHORIZING THE EXECUTION OF AN INTERGOVERNMENTAL
COOPERATION CONTRACT**

WHEREAS, the Village of Savoy Board of Trustees has received the Plan of the Illinois Municipal League Management Association including By-Laws, the Intergovernmental Cooperation Contract, and the anticipated cost of the participation in the Plan; and,

WHEREAS, the Village of Savoy finds it to be in the public interest of the Village to participate in the Plan.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SAVOY, ILLINOIS AS FOLLOWS:

1. That the Savoy Board of Trustees does hereby authorized and approve membership in the Illinois Municipal League Risk Management Association and directs the President and clerk to execute an Intergovernmental Cooperation Contract with the Illinois Municipal League Risk Management Association for membership on an annual basis and each year thereafter unless this Ordinance is repealed.
2. Each Member hereby agrees to contribute to the Association a sum of money to be determined by the Association at the time of its annual renewal based on the needs of the Association and the loss experience of the Member, which sum shall constitute the cost of the Member's contribution for membership in the Association.
3. That this Ordinance shall be effective immediately upon its passage and approval.
