**AN ORDINANCE AMENDING SECTION 5.08.050 OF  
SAVOY MUNICIPAL CODE OF 2003 REGARDING  
NUMBER OF AUTHORIZED CLASS "C" LIQUOR LICENSES**

**WHEREAS**, the Village of Savoy heretofore adopted a Liquor Control Ordinance, namely, ORDINANCE NO. 980401A REGULATING THE SALE AT RETAIL OF ALCOHOLIC LIQUORS WITHIN THE VILLAGE OF SAVOY, ILLINOIS, which has been amended from time to time; and

**WHEREAS**, said Ordinance, as amended, was duly incorporated into the Savoy Municipal Code of 2003 as Chapter 5.08 ALCOHOLIC BEVERAGES; and

**WHEREAS**, Section 5.08.050 of the Savoy Municipal Code of 2003 provides for liquor license fees and the number of liquor licenses authorized by the Village of Savoy; and

**WHEREAS**, Aldi Inc. doing business as Aldi Inc. #92, 605 North Dunlap Avenue, Savoy, Illinois, has applied for a Class "C" license; and

**WHEREAS**, no such Village of Savoy Class "C" license is presently available under Savoy's Liquor Ordinance; and

**WHEREAS**, the President and Board of Trustees have determined that the authorized number of Class "C" licenses, which entitle the licensee to serve alcoholic liquor in the original packages not to be consumed on the premises where sold, should therefore be increased from four (4) to five (5); and

**WHEREAS**, Section 5.08.050 of the Savoy Municipal Code of 2003, as heretofore amended, should be so amended to authorize five (5) Class "C" licenses.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF SAVOY, ILLINOIS, AS FOLLOWS:**

Section 1. Section 5.08.050 regarding the fee, number and display of licenses is amended to read as follows:

Section 5.08.050 Fees, number and display of licenses.

The number of licenses authorized and the annual fee for the license classifications set forth in Section 5.08.050 are as follows:

Each establishment so licensed shall display in some prominent place on the premises the license issued to it, at all times during business hours.

Section 2. All other provisions of said Chapter 5.08, as heretofore amended, shall remain in full force and effect.

Section 3. Invocation of Authority.

This ordinance is enacted pursuant to the authority granted to this Village by the Constitution of the State of Illinois and the Compiled Statutes, including but not limited to 65 ILCS 5/11-13-1.

Section 4. State Law Adopted.

All applicable provisions of the Illinois Compiled Statutes, including the Illinois Municipal Code, as may be amended from time to time, relating to the purposes of this Ordinance are hereby incorporated herein by reference.

Section 5.     Approval and Execution of Documents.

The President and Village Clerk are hereby authorized and directed to execute said documents that are necessary to carry out and give effect to the purpose and intent of this Ordinance.

Section 6.     Other Actions Authorized.

That the President, Village Clerk and Village Attorney are hereby authorized and directed to do all things necessary, essential, or convenient to carry out and give effect to the purpose and intent of this Ordinance.

Section 7.     Acts of Village Officials.

That all acts and doings of the officials of the Village past, present, and future which are in conformity with the purpose and intent of this Ordinance, are hereby in all respects, ratified, approved, authorized and confirmed.

Section 8.     Headings.

The headings for the articles, sections, paragraphs and sub-paragraphs of this Ordinance are inserted solely for the convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provisions of this Ordinance.

Section 9.     Severability.

The provisions of this Ordinance are hereby declared to be severable and should any provision, clause, sentence, paragraph, sub-paragraph, section, or part of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable, and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect. It is hereby declared to be the legislative intent of the Village Board of Trustees that this Ordinance would have been adopted had not such unconstitutional or invalid provision, clause, sentence, paragraph, sub-paragraph, section, or part thereof had not been included.

Section 10.      Superseder and Publication.

All code provisions, ordinances, resolutions and orders, or parts thereof, in conflict herewith, are to the extent of such conflict hereby superseded. A full, true and complete copy of this Ordinance shall be published in pamphlet form as provided by the Illinois Municipal Code, as amended.

Section 11.      Effective Date.

This Ordinance shall be in full force and effect upon passage and approval, as provided by the Illinois Municipal Code, as amended.
