AN ORDINANCE DELETING ENTIRE CHAPTER 6.12 - ANIMAL NUISANCES FROM THE WEST FRANKFORT MUNICIPAL CODE

WHEREAS, the City of West Frankfort, Illinois, is a home rule unit of government pursuant to Section 6, Article VII of the Constitution of the State of Illinois; and

WHEREAS, the corporate authorities of the City of West Frankfort, Illinois believe it advisable and necessary and in the best interests of the City of West Frankfort and the health, safety and welfare of its residents to delete a certain Chapter of the West Frankfort Municipal Code with regard to Animal Nuisances as it is not necessary any longer for the health, safety and welfare of the residents. It is an ordinance from the distant past, 1937.

NOW, THEREFORE, BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF WEST FRANKFORT, FRANKLIN COUNTY, ILLINOIS AS FOLLOWS:

Section 1. **DELETION** – The following Chapter of the West Frankfort Municipal Code is hereby deleted in its entirety :

Chapter 6.12 – Animal Nuisances;

Section 6.12.010- Keeping hogs or other animals in offensive conditions; and

Section 6.12.020- Keeping hogs or other swine between May and October

Section 2. **RECITALS AND FINDINGS.** All recitals and findings stated in the preamble are hereby incorporated herein.

Section 3. **REPEALER.** All ordinances, resolutions, orders, or parts thereof, which conflict with the provisions of this Ordinance, to the extent of such conflict, are hereby repealed.

Section 4. **SEVERABILITY.** If any provision of this Ordinance, or the application of any provision of this Ordinance, is held unconstitutional or otherwise invalid, such occurrence shall not affect other provisions of this Ordinance, or their application, that can be given effect without the unconstitutional or invalid provision or its application.

Each unconstitutional or invalid provision, or application of such provision, is severable, unless otherwise provided by this Ordinance.


Section 5. **AUTHORITY.** The source of power for passing this ordinance is the home rule authority of the City of West Frankfort, Illinois and/or the Illinois Municipal Code.

Section 6. **FULL FORCE.** This Ordinance pertains to the government and affairs of the City, and due to its exigency shall be effective and in full force immediately upon its passage, approval and publication in accordance with law.
