ORDINANCE NO.: 2024-8-19-D

**AN ORDINANCE AMENDING TITLE 2,
ADMINISTRATION AND PERSONNEL,
OF THE MUNICIPAL CODE OF VANDALIA**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
VANDALIA, ILLINOIS:**

SECTION I: That **TITLE 2, ADMINISTRATION AND PERSONNEL**, is amended by the addition of the following chapter to-wit:

CHAPTER 2.25 - SALARIES: ELECTED CITY OFFICERS

SECTION 2.25.010 – MAYOR

The compensation for the office of Mayor from and after May 1, 2025 shall be \$10,000.00 per annum, payable monthly.

SECTION 2.25.020 – CITY CLERK

The compensation for the office of City Clerk shall be an annual salary, payable monthly, as follows:

For the period May 1, 2025 – April 30, 2026: \$53,527.00

For the period May 1, 2026 – April 30, 2027: \$55,668.00

For the period May 1, 2027 – April 30, 2028: \$57,895.00

For the period May 1, 2028 – April 30, 2029: \$60,210.00

SECTION 2.25.040 – ALDERMEN

The compensation for council members from and after May 1, 2025 shall be \$4,873.00 per annum, payable quarterly.

SECTION II: This Ordinance shall be effective as to salary for the offices described aforesaid for the period of May 1, 2025 through April 30, 2029.

SECTION III: This Ordinance shall be in full force and effect beginning May 1, 2025.
